STAFF'S STATUS UPDATE

COMES NOW, the Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively), files this Status Update relevant to Staff's projected Report and Recommendation ("R&R") date in this docket. In support of its Status Update, Staff states as follows:

- 1. On March 19, 2015, Atmos Energy ("Atmos") filed an Application with the Commission seeking to amend its general service firm transportation service tariff (Rate Schedule FT 900) to permit customers who qualify to take service under Rate Schedule 965 (Irrigation Engine Sales Service) to obtain firm transportation service under Rate Schedule FT 900.¹
- 2. As noted in the Commission's Suspension Order issued on April 2, 2015, Staff aimed to complete its R&R by June 30, 2015.²
- 3. Due to Staff's schedule and the press of other Commission business, Staff has determined that there is a slight possibility of being unable to complete its R&R by the original target date.
- 4. Staff continues to make progress towards completing its R&R, and is fast approaching this objective. However, Staff likewise now recognizes that it may not complete its

review by June 30, 2015. While Staff continues to make strides in completing its investigation of Atmos' Application, Staff must respectfully request it be granted the time necessary to ensure a thorough review.

WHEREFORE, Staff respectfully requests the Commission accept this Status Update.
