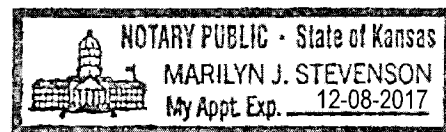

You are hereby notified that Oil Sources Corp. has
filed an Application with the State Corporation Com-
mission of the State of Kansas ("Commission") for ap-
proval of a well location exception and full production
allowable for its Two Bros. lease wells to be drilled at
the following locations:

Two Bros. #10: 1,111' from the West line ("FWL")
and 1,185' from the South line ("FSL"),
Two Bros. #11: 1,111' FWL and 730' FSL,
Two Bros. #12: 1,111' FWL and 470' FSL and
Two Bros. #13: 1,111' FWL and 165' FSL,

protest shall do so in writing and shall state the spe-
cific reasons why the drilling of the Subject Wells at
the locations described above, and the assignment of
a full allowable thereto, will violate correlative rights or
cause waste. Objections or protests shall be mailed to

sas 67202, with a copy mailed to the Applicant's attor-
neys listed below.
