**APPLICATION TO CEASE**

COMES NOW Kansas Gas and Electric Company, doing business as Westar Energy (Westar Energy), and in support of its Application To Cease states:

1. Westar Energy is a Kansas corporation authorized by the Commission to conduct the business of a public utility under the provisions of K.S.A. 66-104, and as such holds a Certificate of Convenience and Authority from this Commission to engage in the business of an electric public utility in the State of Kansas, thereby promoting the public convenience in the following described territory:

**MONTGOMERY COUNTY, KANSAS**

A tract of land described as the Northwest ¼ of the Northeast ¼ of Section 13, Township 33 South, Range 16 East in Montgomery County, Kansas, as detailed on the map marked Exhibit A and attached hereto.

2. Radiant Electric Cooperative, Inc. (Radiant EC) certified territory is adjacent to the territory described in paragraph 1.

3. Westar Energy and Radiant EC have mutually agreed, subject to the Commission's approval, that as a matter of public convenience and to better serve a customer constructing a new home, Radiant EC should serve as an electric public utility in the territory described in paragraph 1.

4. Westar Energy understands that Radiant EC has filed or will soon file an application with the Commission to expand its electric service territory to include the territory described in paragraph 1.

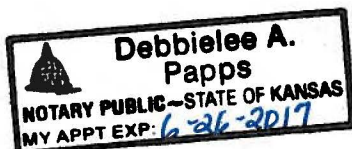

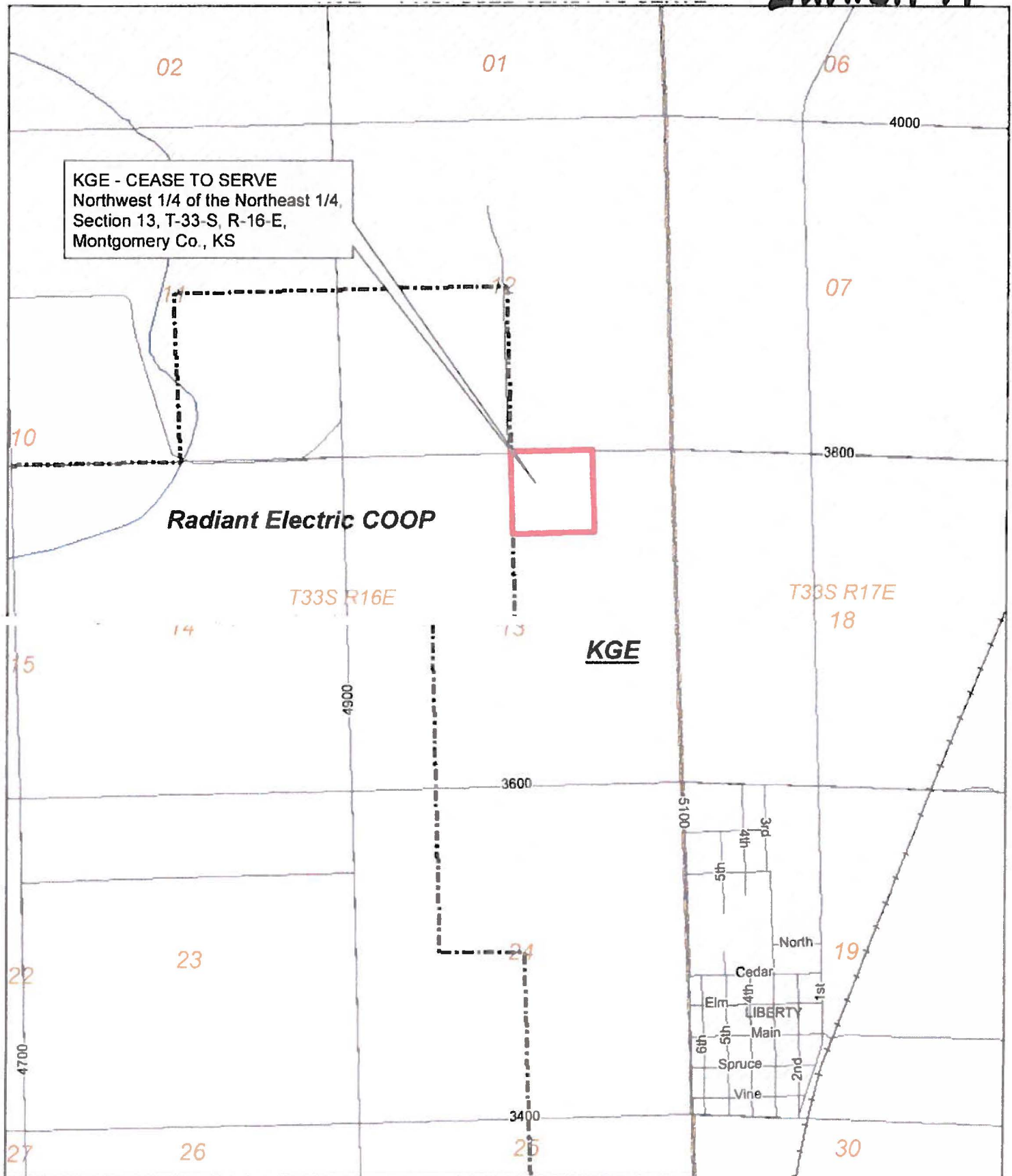
