**JOINT RECOMMENDATION ON DEFINITION FOR SCHOOLS
SUBJECT TO INVESTIGATION**

COME NOW Kansas City Power & Light Company ("KCP&L" or the "Company"), the Staff of the State Corporation Commission of the State of Kansas ("Staff"), and the Olathe Public Schools - Unified School District No. 233 ("Olathe USD 233"), Johnson County Community College ("JCCC"), Spring Hill School District - Unified School District No. 230 ("Spring Hill USD 230"), Blue Valley Schools - Unified School District No. 229 ("Blue Valley USD 229"), and Shawnee Mission School District - Unified School District No. 512¹ ("Shawnee Mission USD 512"), (this group of schools referred to collectively herein as "the Schools"), (all the aforementioned entities referred to collectively herein as "the Parties"), and submit this joint recommendation to the State Corporation Commission of the State of Kansas ("Commission") suggesting an appropriate definition for the schools that will be subject to this general investigation.

1. On June 27, 2019, the Commission issued an "Order Opening General Investigation" in this docket ("Order") wherein the Commission separated the proceeding into three phases. Phase I requires KCP&L, Staff and the Schools to collaborate and submit by July

29, 2019, a joint recommendation suggesting an appropriate definition for the schools that will be subject to this general investigation.²

2. Pursuant to the Commission's directive, the Parties met to discuss this issue and agreed on the following definition:

For the purpose of determining the appropriateness of a separate rate or rates for schools, the General Investigation Study should consider the costs, revenues, and loads associated with the accounts of Olathe Public Schools USD 233, Blue Valley Schools USD 229, Spring Hill School District USD 230, Johnson County Community College, and Shawnee Mission USD 512, plus a selection of other school accounts in the KCP&L-KS service territory resulting in approximately 150 total accounts. Additional school accounts selected will be those of tax supported public schools or private schools that provide education at the elementary, secondary, or college and university levels. An account qualifies as a school account if its primary function is the presentation of formal instruction and it normally maintains a regular faculty and curriculum and normally has a regularly enrolled body of pupils or students in attendance at the place where its educational activities are regularly carried on.

3. The parties agree to work collaboratively to determine an appropriate sample of school accounts to be studied.

4. The Parties submit this definition and jointly recommend it be adopted by the Commission to be used as the definition for the schools subject to the general investigation to be conducted pursuant to the Order.
