ENTRY OF APPEARANCE AND MOTION TO REMOVE CASE FROM  
COMMISSION'S MAY 11, 2021 AGENDA

Undersigned counsel, Mark P. Johnson, enters his appearance on behalf of Sprint Communications Company LP (Sprint), the entity subject to the audit in question.

1. The Commission's agenda for May 11, 2021, which was issued on the morning hereof, indicates that the Commission intends to consider an order arising out of a motion to compel filed by Staff. It appears that the motion was never served on Sprint. Counsel obtained a copy of the motion from the Commission web site's "New Pleadings" section on the morning of the morning hereof. Although the motion includes William Haas in the Certificate of Service, Mr. Haas has indicated to the undersigned that he never received a copy of the motion.

2. Sprint seeks only a short postponement of the Commission's consideration of the subject matter set forth on the May 11 agenda: designation of a presiding officer and setting a hearing on the motion. Sprint requests a postponement of two weeks so that it may consider the motion and confer with Staff to determine whether the dispute addressed in the motion may be resolved short of Commission intervention.

Wherefore, Sprint requests that the Commission remove agenda item 2(A) from the May 11, 2021, agenda, and that the Commission reschedule the item at least two weeks from May 11, so Sprint may review the motion and, in consultation with Staff, take appropriate action.
