MOTION TO CANCEL JANUARY 12, 2022 EVIDENTIARY HEARING AND RENDER DECISION BASED UPON PREFILED TESTIMONY

)

The Staff of the State Corporation Commission of the State of Kansas (Staff), by and through its counsel, files its Motion requesting the Commission to cancel the Evidentiary Hearing scheduled January 12, 2022, and to render a decision based upon the testimony of the parties filed in this Docket. In support of its Motion, Staff states as follows:

1. On September 28, 2021, the Commission opened the immediate Docket to determine the Kansas Universal Service Fund (KUSF) Year Twenty-Six Assessment Rate, effective March 1, 2022, through February 28, 2023, (Year 26) pursuant to K.S.A. 66-2008(a)

and Docket No. 94-GIMT-478-GIT.

2. On December 16, 2021, Sandra K. Reams filed direct testimony on behalf of Staff in this proceeding with several attachments.

3. On December 28, 2021, Douglas Meredith filed rebuttal testimony on behalf of the Rural Local Exchange Carriers (RLECs) in this proceeding.

4. On January 5, 2022, Sandra K. Reams plans to file sur-rebuttal testimony on behalf of Staff.

5. Pursuant to discussions between the parties, there is agreement that the evidentiary hearing in this matter can be cancelled. Staff and the RLECs stipulate to the admission of all Staff and RLEC testimony, waive cross-examination, and request the testimony be included in the record.

6. At the time of this filing, no parties to this Docket expressed opposition to Staff filing this Motion. Staff believes this matter can be resolved efficiently in a summary proceeding before the Commission.

7. The Kansas Administrative Procedure Act (KAPA) allows the Commission to render decisions without holding a hearing, namely in summary proceedings.¹ K.S.A. 77-541(a) provides that "[t]he state agency record for a summary proceeding consists of any documents regarding the matter that were considered . . . by the state agency."

8. The Commission's use of a summary proceeding in this matter would not preclude any party from subsequently requesting a hearing on the order.²

WHEREFORE, for the reasons stated above, Staff respectfully requests that the Commission issue an order cancelling the Evidentiary Hearing scheduled in this proceeding for January 12, 2022, and rendering a decision based upon the pre-filed testimony.
