PREHEARING OFFICER ORDER ADJUSTING PROCEDURAL SCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- 1. On November 5, 2019, the Commission issued a Penalty Order against Lawco Holdings, LLC (Operator) for one violation of K.A.R. 82-3-400 because Operator conducted unauthorized injection at the Radcliff #7-5 well.¹
 - On December 2, 2019, Operator requested a hearing.² 2.
- 3. On January 21, 2020, the Prehearing Officer issued an order setting a procedural schedule. Commission Staff and Operator timely submitted their pre-filed direct testimony, but disruptions associated with COVID-19 have resulted in the need to adjust the remainder of the schedule.3
- 4. At a May 28, 2020, prehearing conference, parties agreed that Staff's pre-filed rebuttal testimony shall be due by June 10, 2020, and the Prehearing Officer so orders it.
