PREHEARING OFFICER ORDER REGARDING ELECTRONIC SERVICE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On March 5, 2020, the Commission issued a *Penalty Order* against Operator for one violation of K.A.R. 82-3-407 because a current and successful mechanical integrity test had not been performed on the Finkenbinder #6-IW well.¹ On April 6, 2020, Operator requested a hearing.²

2. At a May 21, 2020, prehearing conference, all parties consented to the electronic service of all documents³ and orders.⁴ Therefore, the Prehearing Officer directs that service of all documents and orders may be made by email. To the extent practicable, any electronically served document or order shall be attached to the email and served in pdf format. Service of orders is complete upon transmission.⁵ Parties are encouraged to make sure large pdf files do not result in delivery failure and to work together to resolve any email-based service issues.
