### **MOTION TO AMEND PENALTY ORDER**

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively), by and through its counsel, files its motion requesting the Commission amend the Penalty Order issued to Muller Auto Transport LLC (Respondent) on February 6, 2018. In support of its Motion, Staff states as follows:

- 1. Respondent is registered as a motor carrier with the U.S. Department of Transportation (USDOT) and operates under USDOT Number 884531.
- 2. On February 6, 2018, the Commission issued Respondent a Penalty Order assessing it a \$1200 penalty as a result of four (4) violations of the Motor Carrier Safety Regulations found during a Compliance Review conducted on January 10, 2018, by Transportation Division Special Investigator Jared Smith.
- 3. Respondent contacted Transportation Staff and provided additional documentation demonstrating that the carrier obtained and maintained proper Commission authority.
- 4. Staff requests the Commission to issue an Amended Penalty Order, which removes the \$500 penalty alleging the carrier failed to obtain and maintain proper Commission authority in violation of K.S.A. 2016 Supp. 66-1,111 and 49 C.F.R. 392.2, adopted by K.A.R. 82-4-3h, and authorized by K.S.A. 2016 Supp. 66-1,129.

WHEREFORE, for the reasons stated above, Staff respectfully requests that the Commission issue an Order amending the Penalty Order issued on February 6, 2018, to remove a penalty that was previously assessed against the carrier.
