APPLICATION

COMES NOW Berexco LLC (Operator”) for its application in the captioned matter states as follows:

1. Operator is a corporation authorized to do business in the State of Kansas. Operator’s address is 2020 N. Bramblewood, Wichita, Kansas 67206.

2. Operator has been issued by the Kansas Corporation Commission Operator’s License #34318, which expires on October 30, 2017.

3. Operator is the owner and operator of the Dennis Unit #1 WSW well, API #15-081-20731-00-00 (formerly McClain #1-3) which is located in the Southeast Quarter of the Northeast Quarter of the Northwest Quarter of Section 3, Township 29 South, Range 33 West Haskell County, Kansas (“the subject well”). The subject well comprises the following lands:

Dennis Unit: Southeast Quarter Section 34 and Southwest Quarter Section 35, Township 28 South, Range 33 West; Northwest Quarter and North Half Southwest Quarter Section 2 and East Half and East Half Northwest Quarter Section 3,

Township 29 South Range 33 West, Haskell County, KS, containing 960 acres, more or less (“unit premises”).

4. Pursuant to K.A.R. 82-3-111, Operator obtained temporary abandonment status for the subject well on October 1, 1993. The subject well has maintained such status from that date to the present date.

5. On or about August 20, 2009, the Kansas Corporation Commission notified Operator that temporary abandonment status for the subject well would be denied because the subject well had been temporarily abandoned for more than ten (10) years. Operator filed for and received approval for an exception to K.A.R. 82-3-111 on Sept. 13, 2010.

6. On or about September 24th, 2013 the Kansas Corporation Commission notified Operator that the 3 year exception to K.A.R. 82-3-11 was expiring November 17th, 2013. Operator filed for and received approval for an exception to K.A.R. 82-3-111 on April 1, 2014.

7. On or about February 28th, 2017 the Kansas Corporation Commission notified Operator that the 3 year exception to K.A.R. 82-3-11 was expiring April 1st, 2017. K.A.R. 82-3-111 provides for an additional exception to be obtained through an application filed with the commission. Operator seeks such an exception.

8. The subject well has demonstrated mechanical integrity, as evidenced by passage of a mechanical integrity test on March 9, 2017, which was witnessed by a member of the Kansas Corporation Commission staff.

9. Operator is keeping the subject wellbore for use as a back-up water supply well or disposal well for a secondary recovery project on the Dennis Waterflood Unit. Cost to complete this well as a water supply well is estimated at \$100,000, while estimated cost to convert to disposal is \$50,000.

10. Operator has included a plat map showing the locations of all producing, injection, temporarily abandoned, and plugged wells located on the same lease premises as the subject well.

11. Based on the foregoing, Operator requests the Commission grant an additional exception to the 10-year limitation, specifically to allow the subject well to remain eligible for temporary abandonment status for the three (3) years following the April 1st, 2017 expiration of the first exception to the 10-year limitation, subject to yearly renewal with the appropriate Conservation Division District, but without further need to re-apply for a new exception each of the three (3) years prayed for in this application to the Commission.

12. Listed in the attached Exhibit "A" are the names and addresses of the following persons:

- a. Each operator of each oil and gas lease covering lands within one-half (1/2) mile radius of the subject well; and
- b. Each person who owns any mineral interest of record in and under any lands located within one-half (1/2) mile radius of the subject (provided that such mineral interest is not covered by any oil and gas lease).

13. Notice of this application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held in this matter will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, Operator prays that this matter be set for hearing, and upon hearing, that the Commission grant Operator's request for a third exception to the 10-year limitation during which well may be temporarily abandoned pursuant to K.A.R. 82-3-111 so as to allow the subject well to remain temporarily abandoned for three (3) years following the April 1st, 2017 expiration of the exception to the 10-year limitation, subject to yearly renewal with the appropriate Conservation Division District, but without further need to re-apply for a new exception each of the three (3) years prayed for in this application.






