**ORDER NUNC PRO TUNC**

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records, and having been duly advised in the premises, the Commission finds and concludes as follows:

1.        On March 7, 2006, Wildflower Telecommunications, LLC (Wildflower) filed an application seeking authority to provide local exchange and exchange access telecommunications services in the State of Kansas. On May 1, 2006, the Commission issued its Order granting Wildflower's application. In paragraph 5 of the Order, the Commission noted that Wildflower would be limited to serving in the AT&T and Embarq Communications exchanges. In paragraph 18 of the Order the Commission stated that resale and /or interconnection agreements between Wildflower and AT&T and Embarq must be filed with and approved by the Commission.

2.        On December 31, 2013, Wildflower filed a Petition for Order Nunc Pro Tunc, pointing out that notwithstanding the 2006 application and language in the Commission Order, at paragraph 16 of the Order, the Commission granted certification only throughout the AT&T territory. Wildflower states that it is apparent that paragraph 16 contains an inadvertent error by not including the Embarq territory. Wildflower requests the Commission correct the error via a Nunc Pro Tunc order.

3. The Commission agrees that paragraph 16 of the May 1, 2006 order contains an error and it should be corrected, and in that regard the Petition of Wildflower for a Nunc Pro Tunc should be granted.

**IT IS THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. Wildflower's petition is granted and Paragraph 16 of the May 1, 2006 order in the above captioned docket is corrected Nunc Pro Tunc so that paragraph 16 reads as follows:

"The Commission finds that Wildflower should be issued a certificate of convenience and authority in accordance with the provisions of K.S.A. 66-131 to transact the business of a telephone public utility to provide local exchange and exchange access services throughout AT&T and Embarq Communications territories. Wildflower may be subject to the requirements of Section 251(f) of the Telecommunications Act of 1996 should it desire to provide local exchange service in rural areas. "

B. The parties have fifteen (15) days, plus three (3) days if service of this Order is by mail, from the date this Order was served in which to petition the Commission for reconsideration of any issue or issues decided. K.S.A. 66-118b; K.S.A. 2012 Supp. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order, or orders, as it may deem necessary.
