PREHEARING OFFICER ORDER SETTING PREHEARING CONFERENCE

Having reviewed the record, the Prehearing Officer makes the following findings:

- 1. On January 7, 2020, the Commission issued a *Penalty Order* against Operator, finding various violations of K.A.R. 82-3-603 for failure to report and clean up spills on the Wright lease.¹
 - 2. On January 27, 2020, Operator requested a hearing.²
- 3. On February 4, 2020, the Commission assigned a prehearing officer to this docket.³
 No evidentiary hearing has been held; a conference set for March 24, 2020, did not occur.⁴
 - 4. On March 19, 2020, the Commission issued an *Emergency Order Staying All Dockets*. On April 23, 2020, the Commission issued a *Special Order Regarding Conservation Matters*, stating that the *Emergency Order* no longer applied to conservation division matters, and directing that in dockets where a prehearing officer had been assigned but no evidentiary hearing had been held, that a new prehearing conference be set to establish or re-establish deadlines. 6
