
CURB'S MOTION FOR PROTECTIVE ORDER & DISCOVERY ORDER

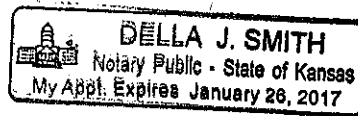
