**TWIN VALLEY TELEPHONE, INC. STATEMENT REGARDING DELAY
OF INITIAL FILING**

COMES NOW Twin Valley Telephone, Inc. ("Twin Valley" or the "company") by its counsel and acknowledges a day's delay in filing its original information herein. The delay in filing was due to an inadvertent and excusable miscommunication between the company's counsel and cost consultant, each of whom believed the other was to submit the electronic filing of the information on the day ordered.


Twin Valley had not filed its information early because it anticipated the Commission's Order approving a Joint Motion by the Company and Commission Staff for waiver of portions of the information required. That Order was approved April 14, 2015 and Twin Valley received confirmation of that approval only around midday on that date. Twin Valley acknowledges Staff's cooperation in addressing the scope and limiting the administrative costs of this proceeding.

Twin Valley fully intended to comply with the Order of the Commission and had all materials prepared in time to meet that order. The voluminous information was in fact made available to Staff through an online "Dropbox" on April 14, and Twin Valley believes the inadvertent delay in formal filing has not materially impeded Staff's ability to perform its function in this proceeding. Twin Valley stands ready to make any

scheduling accommodation necessary to allow Staff full opportunity to perform its functions if the day's delay in formal filing had any actual effect on performance of that function.

Twin Valley regrets its inadvertent filing delay. The company acknowledges and respects the Commission's authority in this matter and intended no lack of such respect by the unintended delay.


