- 1. The Commission is authorized to assess the expenses of a proceeding, opened upon its own motion, on complaint, or upon an application to it, if the expenses attributable to the investigation exceed the sum of \$100.¹ Therefore, if the \$100 threshold is met in this matter, the Commission will assess these expenses against Evergy Kansas Central, Inc.
- 2. Expenses attributable to this docket shall be assessed beginning three (3) days after the notice of assessment is given by service of this Order.
