Pursuant to the Order Clarifying Filing Requirements issued by the Kansas Corporation Commission ("Commission") on December 5, 2012 in Docket No. 12-TPCT-768-ETC, YourTel America Inc. ("YourTel") is required to file a letter notifying the Commission of all revisions to their wireless plans. With this filing, YourTel is notifying the Commission of their new wireless plans.

In compliance with Commission Order in Docket No 12-TPCT-768-ETC, YourTel will continue to pass the entire KUSF Lifeline discount along to its consumers in its entirety. YourTel will also continue to offer to their new and existing Kansas customer's additional calling minutes above and beyond the number of calling minutes provided to Lifeline customers in other states where YourTel does not receive a similar state Lifeline discount. Additionally, in Docket No 12-TPCT-768-ETC, YourTel agreed to provide Kansas Lifeline customers at least 400 free calling minutes in order to be eligible to claim the Lifeline discount for those customers. Therefore, the following revised calling plans still contain 400 or greater calling minutes. These following three plans are replacing all existing plans offered by YourTel.

The rates outlined in the following plans are after state and federal credits are applied and are the final price to our customers.

## Kansas Wireless Lifeline Service 400 Talk and Unlimited Text Plan

This plan includes 400 voice minutes and unlimited text messaging, at no charge each month.

## Kansas Wireless Lifeline Service Unlimited Talk and Text Plan

This plan includes unlimited local voice minutes and unlimited text messaging for \$21.99 per month.

## Kansas Wireless Lifeline Service Unlimited Talk, Text and Web Plan

This plan includes unlimited local voice, unlimited text messaging, and unlimited web use at \$21.99 per month.

All of the above plans include the following features at no additional charge: caller id, call waiting, three way calling, call forwarding and voicemail.
