NOTICE OF PENALTY ASSESSMENT 25-TRAM-320-PEN

This is a notice of a penalty assessment against Flex Solutions LLC ("Flex Solutions") for violations of Kansas Motor Carrier Safety Statutes, Rules, and Regulations discovered during a compliance review conducted from January 15 through February 3, 2025, by Kansas Corporation Commission Special Investigators. The Special Investigators identified forty-three (43) violations of the Motor Carrier Safety regulations. The Penalty for the violation is assessed in accordance with the FY 2025 Uniform Penalty Assessment Matrix, approved by the Commission on June 27, 2024. Flex Solutions has been assessed a \$7,100.00 penalty. For a full description of the penalties and terms and obligations please refer to the Order attached to this notice.

IF YOU ACCEPT THE PENALTY: You have thirty (30) days from the date of service of the Penalty Order to pay the penalty. Please remit payment of \$7,100.00 through your personal account with the Kansas Corporation Commission's Kansas Trucking Regulatory Assistance Network ("KTRAN") system located at https://puc.kcc.ks.gov/ktran/. If you have not received a letter from the Transportation Division assigning you a PIN, please contact that Division at 785-271-3145. You must have an account through KTRAN to pay the penalty owed.

The attached Order also requires a representative of Flex Solutions:

- a. To attend a Commission-sponsored safety seminar within thirty (30) days from the date of the Order. A schedule of dates and locations for safety seminars can be found at the Commission's website http://www.kcc.state.ks.us/trans/safety_meetings.htm.
- b. To submit a written, comprehensive Corrective Action Plan ("CAP") to Transportation Staff within thirty (30) days of the date of this order, documenting the violations described in this Penalty Order, including specific and detailed information explaining Carrier's efforts and concrete steps taken to ensure the violations do not occur in the future.
- c. To submit to one follow-up safety compliance review within eighteen (18) months from the date of this Penalty Order. Transportation Staff will contact the motor carrier at a later date to determine an appropriate time for the review.

IF YOU CONTEST THE PENALTY ORDER: You have the right to request a hearing. A request for a hearing must be made in writing, and within fifteen (15) days from the date of service of this Order, setting forth the specific grounds upon which relief is sought. You may request a hearing through the Commission's electronic filing system found at https://puc.kcc.ks.gov/e-filing/e-express/, and you must also mail a copy of the request for hearing to the undersigned at the above address. If you do not have access to the internet, you can mail an

original and seven copies of the request to the Executive Director at 1500 S.W. Arrowhead Road, Topeka, Kansas 66604, and mail a copy to the undersigned Litigation Counsel. ¹

<u>IF YOU FAIL TO ACT:</u> Failure to pay the penalty of \$7,100.00 within thirty (30) days from the date of service of the Penalty Order or failure to comply with the terms of the Order, or in the alternative, failure to provide a timely written request for a hearing, will result in the Order becoming final and may result in additional sanctions of suspension and/or revocation of your motor carrier operating authority.

PENALTY ORDER

The above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission"). Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. Pursuant to K.S.A. 66-1,108b, 66-1,111, 66-1,112 and 66-1,114b, the Commission is given full power, authority, and jurisdiction to supervise and control motor carriers, as defined in 49 C.F.R. Part 390.5 as adopted by K.A.R. 82-4-3f, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority, and jurisdiction.
- 2. Pursuant to K.S.A. 66-129a, 66-1,130, and 66-1,142b, the Commission may suspend operations, revoke or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision, or regulation of the Commission.

- 3. The Commission has the authority, pursuant to K.A.R. 82-1-237, to investigate an entity under the Commission's jurisdiction and issue an order on the Commission's own motion when the Commission believes the entity is in violation of the law or any order of the Commission.
- Flex Solutions LLC ("Flex Solutions" or "Carrier") is a motor carrier as defined in
 C.F.R. 390.5 and operates under USDOT number 3209589.
- 5. The Commission finds it has jurisdiction over Flex Solutions pursuant to K.S.A. 66-1,108b because it is a motor carrier as defined in 49 C.F.R. Part 390.5 as adopted by K.A.R. 82-4-3f.
- 6. From January 15 through February 3, 2025, a Staff Special Investigator ("SI") completed a safety compliance investigation of Flex Solutions. As a result of the compliance investigation, the SI identified forty-three (43) violations, set forth in fifteen (15) counts, of the Motor Carrier Safety Regulations ("MCSRs"), which carry a penalty set forth in the FY2025 Uniform Penalty Assessment Matrix.¹
- 7. On February 13, 2025, Transportation Staff submitted its Report and Recommendation ("R&R"), attached hereto as "Attachment A" and hereby incorporated by reference herein, recommending a penalty of \$7,100.00 to be issued to Flex Solutions based on the frequency, timeline, and severity of the violations discovered.
- 8. Specifically, pursuant to Staff's R&R, the Commission finds that Flex Solutions committed forty-three (43) violations of the following fifteen (15) counts, discussed more fully in Staff's R&R:²

- a. Count 1: On September 27, 2024, Flex Solutions required or permitted its driver, Joshua Stiles, to operate a commercial driver's license required commercial motor vehicle (a 2015 Kenworth, VIN ending in 7796, GVWR 53,200 lbs., in combination with a 2006 Wabash National trailer, VIN ending 0502, GVWR 68,000 lbs.) in Kansas on a public road in intrastate commerce (Goddard, Kansas to Wichita, Kansas) without first obtaining a negative pre-employment controlled substance test result. As more fully set forth in Staff's R&R, the SI found that Flex Solutions allowed two drivers to perform safety sensitive functions prior to obtaining a negative pre-employment controlled substance test result, which resulted in two (2) violations of 49 C.F.R. 382.301(a)), adopted by K.A.R 82-4-3c. The Commission finds that Staff's recommendation of a penalty of \$650.00 is appropriate and in accordance with the current Penalty Matrix.
- b. Count 2: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) and failed to require its driver to be medically examined and certified. As more fully set forth in Staff's R&R, the SI found that Flex Solutions used three drivers who had not been medically examined and certified, resulting in three (3) violations of 49 C.F.R. 391.45(a), adopted by K.A.R 82-4-3g. The Commission finds that Staff's recommendation of a penalty of \$500.00 is appropriate and in accordance with the current Penalty Matrix.

- c. Count 3: On September 27, 2024, Flex Solutions required or permitted its driver, Joshua Stiles, to operate a commercial driver's license required commercial motor vehicle (a 2015 Kenworth, VIN ending in 7796, GVWR 53,200 lbs., in combination with a 2006 Wabash National trailer, VIN ending 0502, GVWR 68,000 lbs.) in Kansas on a public road in intrastate commerce (Goddard, Kansas to Wichita, Kansas) and failed to maintain a driver qualification file for this driver. As more fully set forth in Staff's R&R, the SI found that Flex Solutions did not maintain a driver qualification file for two drivers, resulting in two (2) violations of 49 C.F.R 395.11, adopted by K.A.R 82-4-3a. The Commission finds that Staff's recommendation of a penalty of \$750.00 is appropriate and in accordance with the current Penalty Matrix.
- d. Count 4: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) without first keeping minimum records of inspection and vehicle maintenance. As more fully set forth in Staff's R&R, the SI found that Flex Solutions had five vehicles for which it had not maintained minimum records of inspection and vehicle maintenance, resulting in five (5) violations of 49 C.F.R 396.3(b), adopted by K.A.R 82-4-3j. The Commission finds that Staff's recommendation of a penalty of \$750.00 is appropriate and in accordance with the current Penalty Matrix.

- e. Count 5: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) without first obtaining an annual inspection for the commercial motor vehicle being operated. As more fully set forth in Staff's R&R, the SI found that Flex Solutions had five vehicles for which it had not obtained annual inspections, which resulted in five (5) violations of 49 C.F.R. 396.17(a), adopted by K.A.R. 82-4-3j. The Commission finds that Staff's recommendation of a penalty of \$750.00 is appropriate and in accordance with the current Penalty Matrix.
- f. Count 6: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) without first paying IFTA or obtaining a fuel permit, which is a violation of K.S.A. 77-34-1409 and 49 C.F.R. 392.2, as adopted by K.A.R. 82-4-3h. The Commission finds that Staff's recommendation of a penalty of \$500.00 is appropriate and in accordance with the current Penalty Matrix.
- g. Count 7: On September 27, 2024, Flex Solutions required or permitted its driver, Joshua Stiles, to operate a commercial driver's license required commercial motor vehicle (a 2015 Kenworth, VIN ending in 7796, GVWR 53,200 lbs., in combination

with a 2006 Wabash National trailer, VIN ending 0502, GVWR 68,000 lbs.) in Kansas on a public road in intrastate commerce (Goddard, Kansas to Wichita, Kansas) without first obtaining Commission authority to operate as a Public (For-Hire) motor carrier, which resulted in one (1) violation of K.S.A. 66-1,111, K.S.A. 66-1,114b and 49 C.F.R 392.2, adopted by K.A.R 82-4-3h. The Commission finds that Staff's recommendation of a penalty of \$500.00 is appropriate and in accordance with the current Penalty Matrix.

- h. Count 8: On September 30, 2024, Flex Solutions required or permitted its owner/driver, Felix Onyango, to operate a commercial driver's license required commercial motor vehicle (a 2013 Kenworth, VIN ending in 4196, GVWR 52,000 lbs.) in Kansas on a public road in intrastate commerce (Hutchinson, Kansas to Wichita, Kansas) without first obtaining valid commercial registration for the commercial motor vehicle operated. As more fully set forth in Staff's R&R, the SI found that Flex Solutions had five vehicles for which it had not obtained valid commercial registration, which resulted in five (5) violations of K.S.A. 8-142 and 49 C.F.R. 392.2 K.S.A. 8-142 adopted by K.A.R. 82-4-3h. The Commission finds that Staff's recommendation of a penalty of \$500.00 is appropriate and in accordance with the current Penalty Matrix.
- i. Count 9: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson,

Mississippi) without first failed to ensure that each driver subject to random alcohol and controlled substances testing has an equal chance of being selected each time selections are made. As more fully set forth in Staff's R&R, the SI found that Flex Solutions had three drivers which had not been added to the random selection list, which resulted in three (3) violations of 49 C.F.R. 382.305(i)(2), adopted by K.A.R.82-4-3c. The Commission finds that Staff's recommendation of a penalty of \$250.00 is appropriate and in accordance with the current Penalty Matrix.

- j. Count 10: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) without first providing educational materials explaining the requirements of Part 382 and the employer's drug and alcohol program policies, which, resulted in one (1) violation of 49 C.F.R. 382.601 (a), adopted by K.A.R. 82-4-3c. The Commission finds that Staff's recommendation of a penalty of \$250.00 is appropriate and in accordance with the current Penalty Matrix.
- k. Count 11: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's licenserequired commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) without first ensuring the person designated to determine that drivers

- undergo reasonable suspicion testing had received 60 minutes training for alcohol and/or 60 minutes of training for controlled substances, which is a violation of 49 C.F.R. 382.603, adopted by K.A.R. 82-4-3c. The Commission finds that Staff's recommendation of a penalty of \$100.00 is appropriate and in accordance with the current Penalty Matrix.
- 1. Count 12: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) without first being enrolled in the Federal Motor Carrier Safety Administration (FMCSA) Drug and Alcohol Clearinghouse (DACH), which is a violation of 49 C.F.R. 382.711(b), adopted by K.A.R. 82-4-3c. The Commission finds that Staff's recommendation of a penalty of \$750.00 is appropriate and in accordance with the current Penalty Matrix.
- m. Count 13: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) without first investigating its driver's background within thirty days of employment, which is a violation of 49 C.F.R. 391.23 (c), adopted by K.A.R. 82-

- 4-3g. The Commission finds that Staff's recommendation of a penalty of \$100.00 is appropriate and in accordance with the current Penalty Matrix.
- n. Count 14: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) and failed to require its driver to prepare a record of duty status. As more fully set forth in Staff's R&R, the SI found that Flex Solutions had failed to require its drivers prepare a record of duty status on eleven (11) transports, which resulted in eleven (11) violations of 49 C.F.R. 395.8(a)(1), adopted by K.A.R.82-4-3a. The Commission finds that Staff's recommendation of a penalty of \$500.00 is appropriate and in accordance with the current Penalty Matrix.
- o. Count 15: On December 3, 2024, Flex Solutions required or permitted its driver, Jose Gonzalez Lopez, to operate a commercial driver's license required commercial motor vehicle (a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs., in combination with a 2008 Utility trailer, VIN ending 9204, GVWR 65,000 lbs.) in Kansas on a public road in interstate commerce (Topeka, Kansas to Jackson, Mississippi) and allowed its driver to operate a commercial motor vehicle after being declared out of service and before the driver may lawfully do so under the rules of Part 395, which is a violation of 49 C.F.R. 395.13 (d), adopted by K.A.R. 82-4-3a. The Commission finds that Staff's recommendation of a penalty of \$250.00 is appropriate and in accordance with the current Penalty Matrix.

- 9. The Commission hereby adopts Staff's findings as contained in its February 13, 2025, R&R.
- 10. The Commission finds that Flex Solutions is required to have a representative responsible for the Carrier's safety compliance attend a Commission-sponsored safety seminar within thirty (30) days from the date of this Order.³ A schedule of the dates and locations for safety seminars can be found on the Commission's website at http://kcc.ks.gov/trans/safety_meetings.htm.
- 11. The Commission further finds that Flex Solutions is required to submit a written, comprehensive Corrective Action Plan ("CAP") that is satisfactory to Transportation Staff within thirty (30) days of the date of this order, documenting the violation(s) described in this Penalty Order, including specific and detailed information explaining Carrier's efforts and concrete steps taken to ensure the violation(s) do not occur in the future.⁴
- 12. The Commission further finds that Flex Solutions is required to submit to one follow-up safety compliance review within eighteen (18) months from the date of this Order at a time agreeable to Staff.⁵
- 13. Failure to comply with the requirements of this Penalty Order shall result in suspension of Flex Solutions' motor carrier operating authority without further notice.⁶
- 14. The Commission concludes the penalty of \$7,100.00 for the one violation set forth above, and the additional three requirements set forth in paragraphs 10, 11, and 12 are just and reasonable.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. Flex Solutions is hereby assessed a \$7,100.00 civil penalty for forty-three (43) violations, set forth in fifteen (15) counts of Kansas law governing the regulation of motor carriers, the Kansas Administrative regulations, and provisions of the Federal Motor Carrier Safety Regulations, as adopted by the Kansas Administrative Regulations.
- B. Flex Solutions is hereby ordered to have a representative responsible for the Carrier's safety compliance attend a Commission-sponsored safety seminar within thirty (30) days from the date of this Order.
- C. Flex Solutions is hereby ordered to submit a written, comprehensive corrective action plan ("CAP") that is satisfactory to Transportation Staff within thirty (30) days of the date of this order, documenting the violations described in this Penalty Order, including specific and detailed information explaining Carrier's efforts and concrete steps taken to ensure the violations do not occur in the future.
- D. Flex Solutions is ordered to submit to one follow-up safety compliance review within eighteen (18) months from the date of this Order at a time agreeable to Staff.
- E. Pursuant to K.S.A. 77-537 and K.S.A. 77-542, any party may request a hearing on the above issue(s) by submitting a written request setting forth the specific grounds upon which relief is sought. The request may be electronically filed with the Commission's electronic filing system at https://puc.kcc.ks.gov/e-filing/e-express/, within fifteen (15) days from the date of service of this Order, and a copy of the request mailed to the Litigation Division. If you do not have access to the internet, you can mail an original and seven copies of the request to the Acting Secretary to the Commission at 1500 S.W. Arrowhead Road, Topeka, Kansas 66604, and mail a copy of the request to Litigation Counsel. A hearing will be scheduled only upon written request.

Failure to timely request a hearing will result in a waiver of Flex Solutions's right to a hearing, and this Penalty Order will become a Final Order.

- F. If a request for hearing is filed, attorneys for all parties shall enter their appearances in Commission proceedings by giving their names and addresses for the record. For civil penalties exceeding \$500.00, a corporation shall appear before the Commission by its attorney, unless waived by the Commission for good cause shown and a determination that such waiver is in the public interest.⁷ For civil penalties of \$500.00 or less, a corporation may appear by a duly authorized representative of the corporation.⁸
- G. If you do not request a hearing, the payment of the civil penalty of \$7,100.00 is due in thirty (30) days from the date of service of this Order. Payment of \$7,100.00 must be made through your personal account with the Kansas Corporation Commission's Kansas Trucking Regulatory Assistance Network ("KTRAN") system located at https://puc.kcc.ks.gov/ktran/. You must have an account through KTRAN to pay the penalty.
- H. Failure of Flex Solutions to perform, pay, or fully comply with the provisions of this Order, including but not limited to Ordering Clauses A through D, above, will result in suspension of Flex Solutions' motor carrier operating authority without further notice. Additionally, the Commission may impose further sanctions to include, but not limited to, the issuance and enforcement of revocation of authority and/or cease and desist orders, and any other remedies available to the Commission by law, without further notice.

EXECUTIVE SUMMARY:

Flex Solutions LLC is a motor carrier (MC) primarily hauling general freight. Flex Solutions LLC operates under USDOT 3209589. From January 15th through February 3, 2025, Commission Staff Special Investigators (SIs) completed a safety compliance investigation of the operations of Flex Solutions LLC. A copy of the safety compliance report is attached hereto as **Exhibit 1** and is hereby incorporated by reference. As a result of this investigation, the SIs identified forty-three (43) violations, set forth in fifteen (15) specific counts, of the Motor Carrier Safety Regulations (MCSRs), which carries a penalty according to the FY2025 Uniform Penalty Assessment Matrix approved by the Commission. Based on the frequency, timeline and severity of the violations discovered by the SIs, staff recommends penalty of \$7,100 be issued to the MC.

DISCUSSION AND ANALYSIS:

On January 15th through February 3, 2025, Commission Staff SIs conducted a safety compliance investigation of the operations of Flex Solutions LLC. The investigation covers a 365 day period and any previous compliance review. Each specific count is detailed below.

Count One (1 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 382.301 (a) states: "Prior to the first time a driver performs safety-sensitive functions for an employer, the driver shall undergo testing for controlled substances as a condition prior to being used, unless the employer uses the exception in paragraph (b) of this section. No employer shall allow a driver, who the employer intends to hire or use, to perform safety-sensitive functions unless the employer has received a controlled substances test result from the MRO or C/TPA indicating a verified negative test result for that driver."

Material Facts and Supporting Documentation: On September 27, 2024, Flex Solutions LLC required or permitted its driver, Joshua Stiles to operate a commercial driver's license (CDL) required commercial motor vehicle (CMV), a 2015 Kenworth, VIN ending in 7796, GVWR 53,200 lbs. in combination with a 2006 Wabash National trailer, VIN ending in 0502, GVWR 68,000 lbs., in intrastate commerce from Goddard, Kansas to Wichita, Kansas. This transport is evidenced by Driver/Vehicle Examination Report No. KSHP02750500, attached hereto as Exhibit 2. At the time of this transport, the MC failed to have a pre-employment controlled substance test completed for its driver, Mr. Stiles. The MC also allowed failed to obtain a pre-employment controlled substance test for Felix Onyango prior to allowing him to perform safety-sensitive functions.

<u>Violation</u>: Flex Solutions LLC used a driver prior to receiving a negative pre-employment-controlled substance test result, which is a violation of 49 C.F.R. 382.301 (a), adopted by K.A.R. 82-4-3c (Exhibit 1, page 3). Two (2) violations were discovered (Exhibit 1, page 20). <u>Recommendations</u>: Staff recommends a fine of \$650, in accordance with the FY2025 Penalty Matrix.

Count Two (2 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 391.45 states:" The following persons must be medically examined and certified in accordance with § 391.43 as physically qualified to operate a commercial motor vehicle:

- (a) Any person who has not been medically examined and certified as physically qualified to operate a commercial motor vehicle;
- (b) Any driver who has not been medically examined and certified as qualified to operate a commercial motor vehicle during the preceding 24 months, unless the driver is required to be examined and certified in accordance with paragraph (c), (d), (e), (f), (g), or (h) of this section; (c) Any driver authorized to operate a commercial motor vehicle only within an exempt intracity zone pursuant to § 391.62, if such driver has not been medically examined and certified as

qualified to drive in such zone during the preceding 12 months;

- (d) [Reserved]
- (e) Any driver who has diabetes mellitus treated with insulin for control and who has obtained a medical examiner's certificate under the standards in § 391.46, if such driver's most recent medical examination and certification as qualified to drive did not occur during the preceding 12 months;
- (f) Any driver who does not satisfy, with the worse eye, either the distant visual acuity standard with corrective lenses or the field of vision standard, or both, in § 391.41(b)(10)(i) and who has obtained a medical examiner's certificate under the standards in § 391.44, if such driver's most recent medical examination and certification as qualified to drive did not occur during the preceding 12 months;

- (g) Any driver whose ability to perform his or her normal duties has been impaired by a physical or mental injury or disease; and
- (h) On or after June 23, 2025, any person found by a medical examiner not to be physically qualified to operate a commercial motor vehicle under the provisions of paragraph (g)(3) of § 391.43."

Material Facts and Supporting Documentation: On December 3, 2024, Flex Solutions LLC required or permitted its driver, Jose Gonzalez Lopez to operate a CDL-required CMV, a 2017 Kenworth, VIN ending in 8299, GVWR 48,000 lbs. in combination with a 2008 Utility trailer, VIN ending in 9204, GVWR 65,000 lbs., in interstate commerce from Topeka, KS to Jackson, MS. This transport is evidenced by the Driver/Vehicle Examination Report No. AR5450000411, attached hereto as Exhibit 3. The MC failed to have drivers Jose Gonzalez, Joshua Stiles and Felix Onyango medically certified as physically qualified to operate a commercial motor vehicle. Violation: Flex Solutions LLC used drivers not medically examined and certified which is a violation of 49 C.F.R. 391.45 (a), adopted by K.A.R. 82-4-3g (Exhibit 1, page 3). Three (3) violations were discovered (Exhibit 1, page 21).

Recommendations: Staff recommends a fine of \$500, in accordance with the FY2025 Penalty Matrix.

Count Three (3 of 15)

<u>Authority</u>: K.S.A. 66-1,111 and 66-1,129

<u>Relevant Statutes</u>: 49 C.F.R 391.51(a) states: "Each motor carrier shall maintain a driver qualification file for each driver it employs. A driver's qualification file may be combined with his/her personnel file.

- (b) The qualification file for a driver must include:
 - (1) The driver's application for employment completed in accordance with § 391.21;
- (2) A copy of the motor vehicle record received from each driver's licensing authority pursuant to § 391.23(a)(1);
- (3) The certificate of driver's road test issued to the driver pursuant to § 391.31(e), a copy of the license or certificate which the motor carrier accepted as equivalent to the driver's road test pursuant to § 391.33, or the original of the written statement providing that the motor carrier determined the driver is not required by § 391.44(d) to complete a road test pursuant to § 391.44(d)(3)(ii)(A) and the original, or a copy, of the driver's certification required by § 391.44(d)(3)(i);
- (4) The motor vehicle record received from each driver's licensing authority to the annual driver record inquiry required by § 391.25(a);
- (5) A note relating to the annual review of the driver's driving record as required by § 391.25(c) (2);
- (6) (i) the medical examiner's certificate as required by § 391.43(g) or a legible copy of the certificate."

<u>Material Facts and Supporting Documentation</u>: This violation took place on September 27, 2024, during the transport described in Count One, above. The MC failed to provide driver qualification files for drivers Joshua Stiles and Felix Onyango.

<u>Violation</u>: Flex Solutions LLC failed to maintain driver qualification file on each driver employed, which is a violation of 49 C.F.R. 391.51 (a), adopted by K.A.R. 82-4-3g. (Exhibit 1, pages 3 to 4). Two (2) Violations were discovered (Exhibit 1, pages 21 to 22).

Recommendations: Staff recommends a fine of \$750, in accordance with the FY2025 Penalty Matrix.

Count Four (4 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

<u>Relevant Statutes</u>: 49 C.F.R 396.3 states: "Every motor carrier and intermodal equipment provider must systematically inspect, repair, and maintain, or cause to be systematically inspected, repaired, and maintained, all motor vehicles and intermodal equipment subject to its control.

(1) Parts and accessories shall be in safe and proper operating condition at all times. These include those specified in part 393 of this subchapter and any additional parts and accessories which may affect safety of operation, including but not limited to, frame and frame assemblies, suspension systems, axles and attaching parts, wheels and rims, and steering systems."

Material Facts and Supporting Documentation: This violation took place during the transport on December 3, 2024, described in Count Two, above. The MC failed to provide minimum records of inspection and vehicle maintenance for the following vehicles: 2017 Kenworth with VIN ending 8299, 2008 Utility trailer with VIN ending 9204, 2015 Kenworth with VIN ending 7796, 2013 Freightliner with VIN ending 4196 and 2006 Wabash National trailer with VIN ending 0502.

<u>Violation</u>: Flex Solutions LLC failed to keep minimum records of inspection and vehicle maintenance, which is a violation of 49 C.F.R. 396.3 (b), adopted by K.A.R. 82-4-3j (Exhibit 1, page 4.) Five (5) violations were discovered (Exhibit 1, pages 23 to 24).

Recommendations: Staff recommends a fine of \$750, in accordance with the FY2025 Penalty Matrix.

Count Five (5 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 396.17 states: "Every commercial motor vehicle must be inspected as required by this section. The inspection must include, at a minimum, the parts and accessories set forth in appendix A to this part. The term commercial motor vehicle includes each vehicle in a combination vehicle. For example, for a tractor semitrailer, full trailer combination, the tractor, semitrailer, and the full trailer (including the converter dolly if so equipped) must each be inspected."

Material Facts and Supporting Documentation: This violation took place during the transport on December 3, 2024, described in Count Two, above. The MC failed to provide annual inspections for the following vehicles: 2017 Kenworth with VIN ending 8299, 2008 Utility trailer with VIN ending 9204, 2015 Kenworth with VIN ending 7796, 2013 Freightliner with VIN ending 4196 and 2006 Wabash National trailer with VIN ending 0502.

<u>Violation</u>: Flex Solutions LLC used a commercial motor vehicle not periodically inspected, which is a violation of 49 C.F.R. 396.17 (a), adopted by K.A.R. 82-4-3j. (Exhibit 1, page 4). Five (5) violations were discovered (Exhibit 1, page 24).

Recommendations: Staff recommends a fine of \$750, in accordance with the FY2025 Penalty Matrix.

Count Six (6 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129.

Relevant Statutes: K.S.A 79-34,109 states: "Imposition of tax; rate; apportionment of tax liability. (a) There is hereby imposed on each interstate motor fuel user a tax on motor fuel used in operations on highways within this state by such interstate motor fuel user. Such tax shall be at the same rate as the current rate of tax applicable to the use or sale of the same motor fuel within this state. The number of gallons of motor fuel used in the operations of any interstate motor fuel user on highways within this state shall be deemed to be such proportion of the total number of gallons of such motor fuel used in its entire operations within and without this state, as the number of miles traveled on highways within this state bears to the total number of miles traveled within and without this state.

- (b) Whenever an interstate motor fuel user uses more than one type of motor fuel upon which different rates of tax are imposed, the tax imposed by this section shall be computed separately for each type of motor fuel, and the sum of the amounts so obtained shall be the amount of the tax imposed by this section. For each type of motor fuel, only the gallons thereof used and the miles traveled therewith shall be counted in making the separate computations for such type of motor fuel.
- (c) If the apportionment provisions of this section do not fairly represent the extent of an interstate motor fuel user's motor fuel use in this state, the interstate motor fuel user may petition for or the director may require in respect to all or any part of such interstate motor fuel user's operations, if reasonable, the employment of any other method to effectuate adequate apportionment of the interstate motor fuel user's tax liability under this act."
- 49 C.F.R. 392.2 states: "Every commercial motor vehicle must be operated in accordance with the laws, ordinances, and regulations of the jurisdiction in which it is being operated. However, if a regulation of the Federal Motor Carrier Safety Administration imposes a higher standard of care than that law, ordinance or regulation, the Federal Motor Carrier Safety Administration regulation must be complied with."

<u>Material Facts and Supporting Documentation</u>: This violation took place during the transport on December 3, 2024, described in Count Two, above. MC failed to have an IFTA or trip permit for this transportation.

<u>Violation</u>: Flex Solutions LLC failed to pay IFTA or obtain a fuel permit, which is a violation of K.S.A. 66-1,111, K.S.A. 77-34-1409 and 49 C.F.R. 392.2, as adopted by K.A.R. 82-4-3h (**Exhibit 1, page 5**). One (1) violation was discovered (**Exhibit 1, page 22**).

Recommendations: Staff recommends a fine of \$500, in accordance with the FY2025 Penalty Matrix.

Count Seven (7 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129.

Relevant Statutes: K.S.A. 66-1,111 states: "No public motor carrier of property or passengers or private motor carrier of property shall operate any motor vehicle for the transportation of either persons or property on any public highway in this state except in accordance with the provisions of this act, and amendments thereto, and other applicable laws."

K.S.A. 66-1,114b states: "Except as hereinafter provided, it shall be unlawful for any public motor carrier to operate as a carrier of property other than household goods or passengers

in intrastate commerce within this state without first having obtained from the commission a certificate of public service to transport property other than household goods or to transport passengers."

49 C.F.R. 392.2 states: "Every commercial motor vehicle must be operated in accordance with the laws, ordinances, and regulations of the jurisdiction in which it is being operated. However, if a regulation of the Federal Motor Carrier Safety Administration imposes a higher standard of care than that law, ordinance or regulation, the Federal Motor Carrier Safety Administration regulation must be complied with."

<u>Material Facts and Supporting Documentation</u>: This violation took place during the transport on September 27, 2024, described in Count One, above. The MC failed to have KCC for-hire authority at the time of this trip. Attached is a copy of the MC KTRAN account showing "No Authority," attached hereto as **Exhibit 4.**

<u>Violation</u>: Flex Solutions LLC failed to obtain proper Commission authority to operate as a Public (For-Hire) MC before conducting intrastate commercial operations, which is a violation of K.S.A. 66-1,111, K.S.A. 66-1,114b and 49 C.F.R 392.2, adopted by K.A.R 82-4-3h (**Exhibit 1, page 5**). One (1) violation discovered (**Exhibit 1, page 22**).

Recommendations: Staff recommends a fine of \$500, in accordance with the FY2025 Penalty Matrix.

Count Eight (8 of 15)

Authority: K.S.A. 8-142

Relevant Statutes: K.S.A 8-142 states: "It shall be unlawful for any person to commit any of the following acts and except as otherwise provided, violation is subject to penalties provided in K.S.A. 8-149, and amendments thereto:

First: To operate, or for the owner thereof knowingly to permit the operation, upon a highway of any vehicle, as defined in K.S.A. 8-126, and amendments thereto, which is not registered, or for which a certificate of title has not been issued or which does not have attached thereto and displayed thereon the license plate or plates assigned thereto by the division for the current registration year, including any registration decal required to be affixed to any such license plate pursuant to K.S.A. 8-134, and amendments thereto, subject to the exemptions allowed in K.S.A. 8-135, 8-198 and 8-1751a, and amendments thereto. A violation of this subsection by a person unlawfully claiming that a motor vehicle is exempt from registration as a self-propelled crane under K.S.A. 8-128(b), and amendments thereto, shall constitute an unclassified misdemeanor punishable by a fine of not less than \$500. A person shall not be charged with a violation of this subsection for failing to display a registration decal on any vehicle except those included under K.S.A. 8-1,101 and K.S.A. 8-143m and 8-1,152, and amendments thereto, up to and including the 10th day following the expiration of the registration if the person is able to produce a printed payment receipt or electronic payment receipt from an online electronic payment processing system for the current 12-month registration period. Any charge for failing to display a registration decal up to and including the 10th day following the expiration of the registration shall be dismissed if the person produces in court a registration receipt for the current 12-month registration period which was valid at the time of arrest."

49 C.F.R. 392.2 states: "Every commercial motor vehicle must be operated in accordance with the laws, ordinances, and regulations of the jurisdiction in which it is being operated. However,

if a regulation of the Federal Motor Carrier Safety Administration imposes a higher standard of care than that law, ordinance or regulation, the Federal Motor Carrier Safety Administration regulation must be complied with."

Material Facts and Supporting Documentation: On September 30, 2024, Flex Solutions LLC required or permitted its driver, Felix Onyango, to operate a CDL-required CMV, a 2013 Kenworth, VIN ending in 4196, GVWR 52,000 lbs., in intrastate commerce from Hutchinson, Kansas to Wichita, Kansas. This transport is evidenced by the Bill Of Lading from Titus Transport Holdings LLC for Felix Onyango, order number 2215294 as Exhibit 5. The MC failed to have current Kansas commercial registration for the vehicle operated during this transport. Attached hereto as Exhibit 6, is email correspondence from KDOR stating Flex Solutions LLC has no commercial registration for the following vehicles: 2013 Freightliner with VIN ending 4196, 2017 Kenworth with VIN ending 8299, 2008 Utility trailer with VIN ending 9204, 2006 Wabash National trailer with VIN ending 0502 and 2015 Kenworth with VIN ending 7796 Violation: Flex Solutions LLC operated a commercial motor vehicle without valid registration. This is a violation of K.S.A. 8-142 and 49 C.F.R. 392.2 K.S.A. 8-142 adopted by K.A.R. 82-4-3h (Exhibit 1, page 5 & 6). Five (5) violations were discovered (Exhibit 1, page 22). Recommendations: Staff recommends a fine of \$500, in accordance with the FY2025 Penalty Matrix.

Count Nine (9 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 382.305 (i) (2) states: "Each driver selected for random alcohol and controlled substances testing under the selection process used, shall have an equal chance of being tested each time selections are made."

<u>Material Facts and Supporting Documentation</u>: This violation took place during the transport on December 3, 2024, described in Count Two, above. The MC failed to have drivers Jose Gonzalez Lopez, Joshua Stiles, and Felix Onyango in the random testing pool. Attached hereto as **Exhibit 7**, is a copy of the MC's random selection list for the 4th quarter.

<u>Violation</u>: Flex Solutions LLC failed to ensure that each driver subject to random alcohol and controlled substances testing has an equal chance of being selected each time selections are made, which is a violation of 49 C.F.R. 382.305(i)(2), adopted by K.A.R.82-4-3c (Exhibit 1, page 6). Three (3) violations were discovered (Exhibit 1, page 20 & 21).

Recommendations: Staff recommends a fine of \$250, in accordance with the FY2025 Penalty Matrix.

Count Ten (10 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 382.601 states: "Each employer shall provide educational materials that explain the requirements of this part and the employer's policies and procedures with respect to meeting these requirements.

(1) The employer shall ensure that a copy of these materials is distributed to each driver prior to the start of alcohol and controlled substances testing under this part and to each driver subsequently hired or transferred into a position requiring driving a commercial motor vehicle.

(2) Each employer shall provide written notice to representatives of employee organizations of the availability of this information."

<u>Material Facts and Supporting Documentation</u>: This violation took place during the transport on December 3, 2024, described in Count Two, above. The MC had no record of a written drug & alcohol policy which met the requirements of part 382.

<u>Violation</u>: Flex Solutions LLC failed to provide educational materials explaining requirements of part 382 and employer's drug and alcohol program policies, which is a violation of 49 C.F.R. 382.601 (a), adopted by K.A.R. 82-4-3c (Exhibit 1, page 6 & 7). One (1) violation was discovered (Exhibit 1, page 21).

Recommendations: Staff recommends a fine of \$250, in accordance with the FY2025 Penalty Matrix.

Count Eleven (11 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 382.603 states: "Each employer shall ensure that all persons designated to supervise drivers receive at least 60 minutes of training on alcohol misuse and receive at least an additional 60 minutes of training on controlled substances use. The training will be used by the supervisors to determine whether reasonable suspicion exists to require a driver to undergo testing under § 382.307. The training shall include the physical, behavioral, speech, and performance indicators of probable alcohol misuse and use of controlled substances. Recurrent training for supervisory personnel is not required."

<u>Material Facts and Supporting Documentation</u>: This violation took place during the transport on December 3, 2024, described in Count Two, above. At the time of this transport, the MC had no individual who attended the required training.

<u>Violation</u>: Flex Solutions LLC failed to ensure the person designated to determine that drivers undergo reasonable suspicion testing receive 60 minutes training for alcohol and/or 60 minutes of training for controlled substances, which is a violation of 49 C.F.R. 382.603, adopted by K.A.R. 82-4-3c (Exhibit 1, page 7). One (1) violation was discovered (Exhibit 1, page 21). <u>Recommendations</u>: Staff recommends a fine of \$100, in accordance with the FY2025 Penalty Matrix.

Count Twelve (12 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 382.711 states: "Each employer and service agent must register with the Clearinghouse before accessing or reporting information in the Clearinghouse."

Material Facts and Supporting Documentation: This violation took place during the transport on December 3, 2024, described in Count Two, above. Attached hereto as Exhibit 8, is a copy of MC's DACH compliance report showing carrier did not enroll in DACH until January 31, 2025.

Violation: Flex Solutions LLC failed to register in the Drug & Alcohol Clearinghouse, which is a violation of 49 C.F.R. 382.711 (b), adopted by K.A.R. 82-4-3c. (Exhibit 1, page 7). One (1) violation was discovered (Exhibit 1, page 21).

Recommendations: Staff recommends a fine of \$750, in accordance with the FY2025 Penalty Matrix.

Count Thirteen (13 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 391.23 states: "Except as provided in subpart G of this part, each motor carrier shall make the following investigations and inquiries with respect to each driver it employs, other than a person who has been a regularly employed driver of the motor carrier for a continuous period which began before January 1, 1971:

(1) An inquiry, within 30 days of the date the driver's employment begins, to each State where the driver held or holds a motor vehicle operator's license or permit during the preceding 3 years, to obtain that driver's motor vehicle record covering that driver's prior 3-year driving history." Material Facts and Supporting Documentation: This violation took place during the transport on December 3, 2024, described in Count Two, above. The MC failed to obtain MVR on driver Jose Gonzalez Lopez within 30 days of his hire.

<u>Violation:</u> Flex Solutions LLC failed to investigate driver's background within 30 days of employment, which is a violation of 49 C.F.R. 391.23 (c), adopted by K.A.R. 82-4-3g (Exhibit 1, page 8). One (1) Violation was discovered (Exhibit 1, page 21).

Recommendations: Staff recommends a fine of \$100, in accordance with the FY2025 Penalty Matrix.

Count Fourteen (14 of 15)

Authority: K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 395.8 states: "Except for a private motor carrier of passengers (nonbusiness), as defined in § 390.5 of this subchapter, a motor carrier subject to the requirements of this part must require each driver used by the motor carrier to record the driver's duty status for each 24-hour period using the method prescribed in paragraphs (a)(1)(i) through (iii) of this section, as applicable."

Material Facts and Supporting Documentation: This violation took place during the transport on December 3, 2024, described in Count Two, above. The MC failed to require drivers to prepare a record of duty status as required by 395.8. Jose Gonzalez-Lopez failed to prepare a record of duty status for transports which required their preparation on November 25, 26, 27, 28, 29, 30, 2024 and December 1, 2, 3, 4, and 5, 2024.

<u>Violation:</u> Flex Solutions LLC failed to require a driver to prepare a record of duty status using the appropriate method, which is a violation of 49 C.F.R. 395.8 (a) (1), adopted by K.A.R. 82-4-3a (Exhibit 1, page 9). Eleven (11) violations were discovered (Exhibit 1, page 22 & 23). <u>Recommendations:</u> Staff recommends a fine of \$500, in accordance with the FY2025 Penalty Matrix.

Count Fifteen (15 of 15)

<u>Authority:</u> K.S.A. 66-1,111 and 66-1,129

Relevant Statutes: 49 C.F.R 395.13 (c) states: "No motor carrier shall:

- (i) Require or permit a driver who has been ordered out of service to operate a commercial motor vehicle until that driver may lawfully do so under the rules in this part.
- (ii) Require a driver who has been ordered out of service for failure to prepare a record of duty status to operate a commercial motor vehicle until that driver has been off duty for the

appropriate number of consecutive hours required by this part and is in compliance with this section. The appropriate consecutive hours off duty may include sleeper berth time." Material Facts and Supporting Documentation: This violation took place during the transport on December 3, 2024, described in Count Two, above. A motor carrier inspection occurred during this trip on December 3, 2024 at 12:10 p.m. The inspector placed driver Jose Gonzalez-Lopez out-of-service for failing to have a record of duty status using the prescribed method as well as not having a valid CDL (See Exhibit 3). However, Mr. Gonzalez-Lopez resumed operations in defiance of the out-of-service designation, completing the trip, as evidenced by the receiving report, attached hereto as Exhibit 9, which shows the load Mr. Gonzalez Lopez picked up on December 2, 2024, at 10:12 p.m. was delivered on December 5, 2024 at 8:14 a.m. Violation: Flex Solutions LLC allowed driver Jose Gonzalez-Lopez to operate a commercial motor vehicle after being declared out of service and before the driver may lawfully do so under the rules of Part 395, which is a violation of 49 C.F.R. 395.13 (d), adopted by K.A.R. 82-4-3a (Exhibit 1, page 9). One (1) violation was discovered (Exhibit 1, page 23). Recommendations: Staff recommends a fine of \$250, in accordance with the FY2025 Penalty Matrix.

RECOMMENDATION:

Transportation Staff recommends the Commission find Flex Solutions LLC committed forty three (43) violations accounting for fifteen (15) specific counts of Kansas law that governs MCs, including various provisions of the Federal Motor Carrier Safety Regulations (FMCSRs), as adopted by the Kansas Administrative Regulations (K.A.R.s), and is therefore subject to sanctions or fines imposed by the Commission.

Due to the frequency, timeline and severity of the violations, Staff recommends a civil penalty of \$7,100 for forty three (43) violations of the MC Safety Statutes, Rules and Regulations, in accordance with the recommended penalties listed in the applicable Uniform Penalty Assessment Matrix.

Staff further recommends Flex Solutions LLC require a representative responsible for the company's safety to attend a Commission-sponsored safety seminar within thirty (30) days from the date of the Order, and provide Litigation Counsel with written proof of attendance. A schedule of the dates and locations for safety seminars can be found on the Commission's website at http://kcc.ks.gov/trans/safety_meetings.htm.

Staff further recommends Flex Solutions LLC submit a written, comprehensive Corrective Action Plan (CAP) to Transportation Staff within thirty (30) days of the date of this order, documenting the violation(s) described in the Penalty Order, including specific and detailed information explaining the carrier's efforts and concrete steps taken to ensure the violation(s) do not occur in the future.

Finally, Staff recommends that Flex Solutions LLC submit to one follow-up safety compliance review within eighteen (18) months from the date of the Penalty Order. Transportation Staff will contact the motor carrier at a later date to determine an appropriate time for the review.


