**MOTION OF WITHDRAWAL**

Coffeyville Resources Refining & Marketing, LLC ("CRRM") hereby withdraws its Complaint Against Mid-America Pipeline Company, LLC ("MAPL") For Violation of Orders of the Kansas Corporation Commission ("KCC"), For Charging Rates and Conditions Without KCC Approval, and For an Order Requiring MAPL to Comply with KCC Orders, and For Emergency Hearing of Complaint ("Complaint") filed on January 3, 2012, in KCC Docket No. 12-MDAP-488-COM.

Notwithstanding the foregoing, by this withdrawal CRRM does not in any manner whatsoever, waive, compromise, or settle any rights, claims, or damages of any amount and type, that it may have pursuant to the 2005 Pipeage Contract or Amended Capacity Lease and Operating Agreement for the period from September 1, 2005 to the present.

WHEREFORE, on the basis of the above and pursuant to the Settlement Agreement filed in KCC Docket No. 12-MDAP-068-RTS, CRRM withdraws its Complaint in KCC Docket No. 12-MDAP-488-COM.


