SUSPENSION ORDER

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

- 1. On May 17, 2013, Suburban Water, Inc. d/b/a Suburban Water Company ("Suburban") filed an Application requesting authority from the Commission to adjust its rates and accompanying tariffs based on a Commission approved Settlement Agreement in Docket No. 12-SUBW-359-RTS.
- 2. Commission Staff ("Staff") has determined that 240 days is needed to fully review Suburban's Application and suspension is required to allow sufficient time for Staff to review and investigate the matter.
- 3. The Commission finds and concludes that suspension of the Application and deferral of its effective date are required to allow sufficient time for full investigation of this matter. The Application should be suspended for a period of 240 days from the date the Application was made, May 17, 2013, until January 12, 2014, pursuant to K.S.A. § 66-117(c).

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. Pursuant to K.S.A. 66-117(c), the Application in the above-captioned docket shall be suspended and the effective date deferred until January 12, 2014.
- B. The parties have fifteen (15) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 77-529(a)(1).
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of issuing such further order, or orders, as it may deem necessary.
