**PREHEARING OFFICER'S ORDER GRANTING MOTION FOR
ADMISSION PRO HAC VICE OF MARGARET ANNE MCGOLDRICK AS
ATTORNEY FOR THE KANSAS POWER POOL, A MUNICIPAL AGENCY**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. On March 16, 2012, the Commission designated Holly L. Fisher, Litigation Counsel, to act as Prehearing Officer in this proceeding.¹ Having examined its files and records, and being duly advised in the premises, the Prehearing Officer makes the following findings and conclusions:

I. Background

1. On March 8, 2012, Kansas Power Pool (KPP) counsel, Curtis M. Irby, pursuant to Supreme Court Rule 116, filed a motion for Admission Pro Hac Vice of Margaret Anne McGoldrick to appear and participate as counsel for KPP in this proceeding.

2. The motion stated that Mr. Irby would act as co-counsel with Ms. McGoldrick, that Ms. McGoldrick is not a Kansas resident but a licensed attorney in good standing in the District of Columbia. The motion stated that Ms. McGoldrick has never been suspended, disbarred or resigned as a result of a disciplinary charge, investigation, or proceeding from the practice of law in any jurisdiction. The motion was accompanied by a verified affidavit of Ms.

McGoldrick indicating that Ms. McGoldrick is counsel for the KPP, the KPP is represented by Kansas counsel Curtis M. Irby, that Ms. McGoldrick is admitted to practice in the District of Columbia, and that she is in good standing in the District of Columbia, has never been suspended, disbarred nor resigned from the practice of law in any jurisdictions as a result of a disciplinary charge, investigation or proceeding, and is not currently the subject of disciplinary action or proceeding in any jurisdiction. The affidavit set forth an address for Margaret Anne McGoldrick, Spiegel & McDiarmid LLP, 1333 New Hampshire Avenue, NW, Washington, DC 20036.

3. No party has objected to the motion. The Prehearing Officer grants the motion and finds that Margaret Anne McGoldrick be admitted Pro Hac Vice in this docket.


Wherefore, the Prehearing Officer makes the following findings and recommendations:


