APPLICATION

COMES NOW, F.G. Holl Company, L.L.C. "Applicant" in support of its Application in the above captioned matter and states as follows:

1. Applicant is a Kansas limited liability company duly authorized by the Kansas Corporation Commission and is in good standing with the Kansas Secretary of State's office to do business in Kansas with a mailing address of 9431 E. Central Avenue, Suite 100, Wichita, Kansas 67206.

2. The Commission has issued F.G. Holl Company, L.L.C. oil and gas operator's License No. 5056, which is in full force and in effect through June 30, 2020.

3. Applicant is the owner and operator of the ILS Land "A" #1-1 well, API# 15-009-26209-0001 located in Barton County, Kansas:

30' South & 130' East of the southeast quarter of the northwest quarter of the northeast quarter of Section 1, Township 19 South, Range 14 West.

4. K.A.R. 82-3-100 states that the Commission may grant an exception to the requirement of any of its regulations.

5. Applicant respectfully requests an exception to the deadline for closing the drilling pits as provided in K.A.R. 82-3-602. Applicant has received a six months extension and one Exception but due to excessive moisture from rainfall and snow received in the past several weeks following extremely wet spring and summer last year, applicant is not able to close the drilling pits at the moment. Applicant is seeking a second Exception of at-least 60 days. Applicant will make every effort to close pits within the requested 60 days.

6. Applicant already hauled off all the drilling fluids from the steel pits on April 4, 2018 and from haul off pits on March 29, 2018. Any fluid in the pits is fresh water from rainfall and snow.

7. Applicant has been unable to close the pits within the recommended 365 days from date of spud and also during the two three-month extensions previously granted by the commission and

Exception, due to persistent rainfall as well as snow from the time the well was drilled. The second three months extension expired on September 19, 2019 and Exception expired on February 10, 2020.

8. The names and address of land owners on whose land the subject well and pits are located are: ILS Land, L.L.C., Attention: Debbie Devorss, 551 A SW 30 Road, Great Bend, Kansas 67530. Exhibit "A" is attached and lists names and addresses of all un-leased mineral owners and operators of leases of record within one-half (1/2) mile radius of the subject well.

9. Applicant also submits Exhibit B which is a plat map showing location of the ILS Land "A" #1-1 well.

10. Notice of this Application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held in this matter will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, F.G. Holl Company, LLC prays that this Application be granted administratively without a hearing, or in the alternative be set for hearing, and upon hearing that the Commission grant Applicant's request, for an exception to the K.A.R. 82-3-602 three hundred sixty five days from well spud date and two three-months extensions after that if needed.


