- 1. The Commission is authorized to assess the expenses of a proceeding, opened upon its own motion, on complaint, or upon an application to it, if the expenses attributable to the investigation exceed the sum of \$100.\frac{1}{2}\$ Therefore, if the \$100 threshold is met in this matter, the Commission will assess these expenses against Wheat State Telephone Company, Inc. d/b/a Wheat State Technologies, WST.
- 2. Expenses attributable to this docket shall be assessed beginning three (3) days after the notice of assessment is given by service of this Order. Wheat State Telephone Company, Inc. d/b/a Wheat State Technologies, WST is hereby notified that it has the right to request a hearing regarding this assessment in accordance with the provisions of the Kansas administrative procedure act, K.S.A. 77-501 *et seg*.²

THEREFORE THE COMMISSION ORDERS THAT:

- A. Wheat State Telephone Company, Inc. d/b/a Wheat State Technologies, WST is assessed the costs of this proceding.
- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).³
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
