ORDER GRANTING UNOPPOSED MOTION FOR MODIFIED PROCEDURAL SCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings and conclusions:

1. As a condition of the merger in Docket No. 18-KCPE-95-MER, both Evergy Kansas Central, Inc.¹ and Evergy Kansas Metro, Inc.² are required to file Earnings Review and Sharing Plan (ERSP) compliance filings by March 31, 2020.³ Staff and the Citizens' Utility Ratepayer Board (CURB) may file a report or testimony if they disagree with the ERSP filing by May 31, 2020;⁴ and Evergy Kansas Central and Evergy Kansas Metro may respond to Staff and CURB by June 30, 2020, with the Commission issuing an order on the dispute by August 31, 2020.⁵

2. Due to the statewide government shut-down, the Commission's docket room was not accepting filings on March 31, 2020. Therefore, Evergy Kansas Central and Evergy Kansas Metro filed their ERSP compliance filing on April 6, 2020.

3. Because of the delayed ERSP filing, and Staff granted Evergy an internal extension on its Annual Report filings from May 1, 2020, to May 15, 2020, which Staff uses to review the ERSP information, Staff requests extending all scheduling deadlines by two weeks. Specifically, Staff requests moving Staff's and CURB's response deadline to June 15, 2020; Evergy's response deadline to July 31, 2020, and the Commission Order deadline (if needed) to September 14, 2020.⁶

4. Staff has contacted Evergy and CURB and neither party expressed opposition to the Motion.

5. Finding the requested extension reasonable in light of the COVID-19 related delays, the Commission adopts the following Modified Procedural Schedule:
