ORDER DESIGNATING NEW PREHEARING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1. On November 27, 2018, the Commission issued a *Penalty Order* against Agricultural Energy Services (Operator) for one violation of K.A.R. 82-3-107 and K.A.R. 82-3-130, for failure to submit a complete and accurate well completion report for the subject well, with associated documents, within 120 days of the spud date.¹

2. The Commission designates Jonathan R. Myers, Assistant General Counsel, 266 N. Main Street, Suite 220, Wichita, KS 67202, 316-337-6245, j.myers@kcc.ks.gov, as the new Prehearing Officer.² The Prehearing Officer may conduct Prehearing Conferences necessary to address any appropriate matters, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other Staff members to serve in this capacity.
