MOTION TO AMEND PENALTY ORDER

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively), by and through its counsel Ahsan A. Latif, file this Motion requesting the Commission issue an Amended Penalty Order reducing the penalty assessed to Moly Manufacturing, Inc. (Moly Manufacturing), by fifty-percent (50%) less than the penalty assessed in the Penalty Order dated June 27, 2017. In support of this Motion, Staff states as follows:

- 1. On June 27, 2017, a Penalty Order was issued to Moly Manufacturing assessing it a penalty of \$650 for one (1) violation(s) of Kansas law that governs motor carriers, including various provisions of the Federal Motor Carrier Safety Regulations (FMCSRs), as adopted by the Kansas Administrative Regulations. The violations were found during a Safety Compliance Review conducted by Special Investigator(s) Gregory Askren on June 1, 2017.
- 1. The Notice of Penalty Assessment advised Moly Manufacturing it was a New Entrant carrier and was eligible for a fifty-percent (50%) reduced penalty if it submitted a signed and dated Reduced Penalty Agreement within fifteen (15) days from the date of the Penalty Order, stating it will comply with the reduced penalty option terms and obligations stated therein.
- 2. On July 6, 2017, Moly Manufacturing submitted the Reduced Penalty Agreement.

 The Corrective Action Plan was submitted by the carrier and has been approved by

Transportation Staff. The Reduced Penalty Agreement is attached hereto and is hereby incorporated by reference.

- 3. Staff recommends the Commission issue an Amended Penalty Order assessing Moly Manufacturing a reduced penalty of \$325 (50% less than originally assessed) and requesting it to comply with the following terms and obligations:
 - a. within thirty (30) days from the date of the Penalty Order dated June 27, 2017
 Moly Manufacturing shall send an individual responsible for safety
 compliance to attend a Commission-sponsored safety seminar, and proof of
 attendance must been submitted to Litigation Counsel;
 - b. within eighteen (18) months of the Penalty Order dated June 27, 2017, Moly
 Manufacturing must submit to a follow-up Safety Compliance Review.
 Transportation Staff will contact the carrier to set up the review; and
 - c. within (30) days from the date of service of the Amended Penalty Order, Moly Manufacturing must make the payment of \$325 through the KTRAN system located at https://puc.kcc.ks.gov/ktran/.

WHEREFORE, for the reasons set forth herein, Staff requests an Amended Penalty Order be issued by the Commission assessing Moly Manufacturing, Inc. a reduced penalty of \$325 and ordering it to comply with the proposed terms and obligations set out in paragraph 3 above.

REDUCED PENALTY AGREEMENT

Moly Manufacturing, Inc. hereby submits this Reduced Penalty Agreement to become eligible for a fifty percent (50%) reduction in the penalty assessed in the Penalty Order dated June 27, 2017. Moly Manufacturing has agreed to comply with the following terms and obligations:

- 1. Moly Manufacturing has submitted, within fifteen (15) days from the date of the Penalty Order issued on June 27, 2017, this signed and dated Reduced Penalty Agreement to Litigation Counsel at the above address.
- 2. Moly Manufacturing will, within 30 days from the date of the Penalty Order dated June 27, 2017, submit to Transportation Staff a Corrective Action Plan (CAP) documenting the violation(s) and describing specific and detailed information explaining the its efforts and concrete steps taken to ensure the violation(s) do not occur in the future. I understand the CAP must be approved by Transportation Staff before my company can be eligible for the 50% reduced penalty.
- 3. Moly Manufacturing will, within thirty (30) days from the date of the Penalty Order dated June 27, 2017, send an individual responsible for safety compliance to attend a Commission-sponsored safety seminar, and proof of attendance will be submitted to the Litigation Counsel.
- 4. Moly Manufacturing will be available within eighteen (18) months from the date of the Penalty Order for a follow-up Safety Compliance Review. Transportation Staff will contact the carrier to schedule the review.

Moly Manufacturing, Inc. understands that if approved, Transportation Litigation Counsel will file a Motion for Amended Penalty Order with this Agreement attached to the motion. The Amended Penalty Order will assess Moly Manufacturing a fifty-percent (50%) reduced penalty of \$325, and set out the terms and conditions stated above. Once the Amended Penalty Order is issued by the Commission, Moly Manufacturing will have thirty (30) days from the date of service of the Amended Order to pay the reduced penalty assessed.
