Dear Ms. Retz:


On August 18, 2022, the Kansas Corporation Commission (KCC or Commission) issued an Order adopting Vantage Point Solutions' (VPS) Audit Report and directed Fonality, Inc. (Fonality or Company) to: (1) take corrective action to change its reporting procedures for filing CRWs and showing the amount of KUSF surcharge actually collected from customers in Box C; and (2) file an affidavit or a corporate officer attesting to the new procedures. These actions were to be taken within 30 days from the issuance of the Order, or September 19, 2022.

On September 21, 2022, Fonality submitted to VPS its affidavit, signed by a corporate officer, stating the new procedures had been implemented. VPS filed the affidavit on September 22, 2022.

Fonality has complied with the August 18, 2022, Order.

VPS recommends that the Commission determine Fonality is in compliance with the Commission's Order and that Docket No. 22-FNYV-032-KSF be closed.
