# PETITION OF KANSAS ELECTRIC POWER COOPERATIVE, INC. TO INTERVENE

Comes now Kansas Electric Power Cooperative, Inc. (KEPCo) and moves the Corporation Commission of the State of Kansas (Commission) for an order pursuant to K.S.A. 77-521 and K.A.R. 82-1-225 permitting it to intervene in the above captioned proceeding. In support of its petition, KEPCo alleges and states as follows:

1. KEPCo is a corporation duly organized under the laws of the State of Kansas, with its principal place of business at 600 SW Corporate View, Topeka, Kansas 66615. It is authorized to do business and is conducting business in the State of Kansas.

2. KEPCo is engaged in the business of a generation and transmission cooperative electric supplier providing power and energy to 19 member distribution cooperatives in the State of Kansas, serving approximately 300,000 consumer members.

3. KEPCo takes transmission service from Mid-Kansas for service to a number of its Members.

4. On November 13, 2012, Mid Kansas Electric Company, LLC (Mid-Kansas) submitted its Open Access Transmission Tariff (OATT) for filing pursuant to the Commission's October 31, 2012 *Order on Stipulation and Agreement and Amendment to Stipulation and Agreement,* issued in Docket No. 12-MKEE-650-TAR (650 Docket). Pursuant to the October 31 Order, this docket will be used for future true-up and annual update filings implementing the formula based rate approved in the 650 Docket.

5. KEPCo will be directly affected by both the terms of the OATT and the contemplated true-ups and annual updates thereto, and, ultimately, its members will or may be bound by any Commission order or activity in this proceeding, and KEPCo and its members may be adversely affected thereby.

6. KEPCo's interest herein is not adequately represented by any other party.


