- An Order Approving Westar Energy, Inc. and Kansas Gas and Electric
 Company's (Westar) Annual Energy Cost Correction Adjustment Factor was issued in this docket on September 14, 2014.
- 2. Staff's recommended in its Report and Recommendation that the Commission approve an increase of \$5,305,118 for Westar's ACA filing, which results in 0.0303 cents per kWh to be collected from Kansas customers. However, in paragraphs 5, 6, 7, and B the Order misstated 0.0303 cents per kWh as \$0.0303 per kWh. The Commission corrects these errors by changing \$0.0303 per kWh in paragraphs 5, 6, 7, and B to 0.0303 cents per kWh.
