**WITHDRAWAL OF MOTION TO SUSPEND INTRASTATE
MOTOR CARRIER OPERATIONS**

The Staff of the State Corporation Commission of the State of Kansas (Staff), by and through its counsel, files a withdrawal of its motion to suspend JSB Landservices LLC of Colwich, Kansas (Carrier) from intrastate commercial motor carrier operations. In support of its Withdrawal, Staff states as follows:

1. On January 30, 2024, the Commission issued Carrier a Penalty Order that assessed a civil penalty of \$1,000 for violations of the Kansas Motor Carrier Safety Statutes, Rules and Regulations discovered during a compliance review conducted by Special Investigator Doug Handy on January 17, 2024.
2. The Carrier was served with the Penalty Order on February 12, 2024. The Carrier had 30 days from the date served to pay the civil penalty of \$1,000.
3. Carrier was sent a collection letter on March 5, 2024, reminding it of the amount due and giving it 10 days from the date of the collection letter to pay.
4. As of April 8, 2024, Commission records indicate that Carrier had not complied with the collection letter or the requirements of the Penalty Order.

5. On April 8, 2024, Staff filed its Motion to Suspend Intrastate Motor Carrier Operations.

6. On April 9, 2024, Carrier paid its outstanding civil penalty.

7. Carrier's actions obviate the need to be suspend the Carrier's intrastate motor carrier operations. Therefore Staff withdraws its motion and requests this docket be closed.

WHEREFORE, for the reasons stated above, Staff respectfully withdraws its Motion to Suspend Intrastate Motor Carrier Operations and requests this docket be closed.
