**SECOND JOINT STATUS REPORT**

COME NOW ONEOK Field Services Company ("Field Services") and Aquila, Inc. ("Aquila") and, pursuant to Paragraph 7 of the Commission's Prehearing Conference Order issued in this Docket on April 15, 2005, and the Joint Status Report filed herein on June 14, 2005 (the "First Report"), jointly submit to the Commission the following second status report as to the parties' progress in resolving the issues raised by Aquila's complaint herein:

1. The parties have continued to communicate regarding the issues raised by Aquila's complaint herein, but have not had any further formal settlement meetings since their last meeting on May 19, 2005.
2. In regard to Paragraph 1(c) of the First Report, Field Services has advised Aquila that Field Services has completed the survey of each of Aquila's customer locations.
3. In regard to Paragraph 1(d) of the First Report, Field Services is continuing to work on a draft "decision tree" to utilize in the decision-making process for the ability to safely deliver gas. Field Services anticipates completion of the draft by September 15, 2005, and plans to submit the draft and the customer location surveys to Aquila for its review and comment.

4. In regard to Paragraph 1(f) of the First Report, Field Services is preparing a request to Northern Natural Gas Pipeline Company (“NNG”) to make available to Aquila the telemetry data relating to hydrogen sulfide levels to which OFS has access. Field Services plans to submit the request to NNG by August 25, 2005.

5. In regard to Paragraph 1(g) of the First Report, Aquila submitted Data Requests to Field Services on July 14, 2005. Field Services submitted a written response to the Data Requests on July 26, 2005, and produced documents on August 12, 2005.

6. In regard to Paragraph 1(h) of the First Report, after providing notice of curtailment in accordance with the recently enacted legislation (House Bill No. 2263), the residential customer meter was disconnected on July 26, 2005.

7. In regard to Paragraph 1(i) of the First Report, Field Services is continuing to work on the removal of the odorant pots.


8. In regard to Paragraph 1(j) of the First Report, Field Services is preparing an updated low pressure list and will provide that list to Aquila by the September 1<sup>st</sup> deadline required by the Commission.

9. The parties believe that progress has continued to be made in this Docket, such that they do not recommend that the Commission adopt a formal procedural schedule in this Docket at this time. The parties recommend that another status report be filed with the Commission on or before September 30, 2005.

WHEREFORE, the parties respectfully request that the Commission accept this Second Joint Status Report and approve it as evidencing satisfactory progress of the parties toward reaching settlement of the issues in this Docket, and approving the parties’ joint recommendation that a further Status Report be filed with the Commission on or before


September 30, 2005, and, if necessary and appropriate, recommending to the Commission a procedural schedule to be adopted and followed in this Docket.
