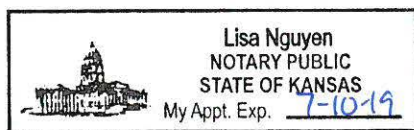


AFFIDAVIT IN SUPPORT OF MOTION FOR ADMISSION OF ALAN I. ROBBINS




