### ORDER DESIGNATING NEW PREHEARING OFFICER

including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other Staff members to serve in this capacity.

4. Although a Prehearing Officer is designated in this docket, parties are still required to file pleadings with the Commission, and filings shall be made with the Commission's Docket Room before 5:00 p.m., on the date scheduled for service. Any electronic service received after the deadline set forth in the procedural schedule, or any filing made after 5:00 p.m., on the date scheduled for service, shall be accompanied by a Motion to File Out of Time.

6. The Prehearing Conference is scheduled for **Tuesday**, **May 2, 2017**, at **8:30 a.m.** by telephone.

### THEREFORE, THE COMMISSION ORDERS:

- A. Samuel Feather is designated as the new Prehearing Officer.

- C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it may deem necessary.
