STATUS UPDATE TO COMPLIANCE AGREEMENT

On July 21, 2020, the Commission issued an *Order Approving Compliance Agreement* (Agreement) in this docket. The Agreement originally addressed 27 wells, requiring Operator to obtain compliance at three wells per quarter beginning September 30, 2020.¹ To date, Operator has brought 26 wells into compliance with the terms of the Agreement. Additionally, 21 wells have been added to the agreement and the final deadline has been extended to June 30, 2024. The Agreement provides that it may be amended to include additional wells with the written consent of the District Supervisor.²

The District #3 Supervisor recommends amending this Agreement to include the Chi-Chi #2-1D-1, API #15-011-23995; Cromer #11-22, API #15-011-24034; Dunlop #1-12, API #15-011-23853; Emmerson Farms #16-15A-3, API #15-011-24032; Hoppe #2, API #15-103-20388; Hoppe #4, API #15-103-20457; McClintick #7, API #15-037-19386; McClintick #8, API #15-037-19387; New Horizons #6-26, API #15-011-23857; S. Hoppe #3, API #15-103-20360; Snow #11-5D-3, API #15-107-24439; and Snow #14-5A-1, API #15-107-24468 wells (Subject Wells).³ Operator has indicated it is not opposed to the addition of the Subject Wells to the

Agreement. Further, Staff recommends the final compliance deadline be extended to June 30, 2025.
