ORDER GRANTING THE CITIZENS' UTILITY RATEPAYER BOARD INTERVENTION

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On February 20, 2015, Westar Energy, Inc. (Westar Energy) filed an Application with the Commission for a siting permit granting Westar the right to construct a 345 kV transmission line from Westar's Jeffrey Energy Center Substation to Westar's East Manhattan Substation, located near Manhattan, Kansas.
- 2. On March 12, 2015, the Citizens' Utility Ratepayer Board (CURB) filed its Petition to Intervene, citing its statutory authority to represent residential and small commercial ratepayers. CURB explained the rates paid by and the services received by residential and small commercial customers may be substantially affected by this proceeding.¹
- 3. The Commission finds CURB has demonstrated an interest in this proceeding.

 Therefore, pursuant to K.S.A. 77-521, the Commission grants CURB's Petition for Intervention.
