PROTEST BY KAREN LEE BYERLEY, TRUSTEE OF THE KAREN LEE BYERLEY REVOCABLE TRUST DATED JULY 1, 2019 AND LOUISE ANN WEST TO THE APPLICATION OF CANADAY OIL CORPORATION FOR EXCEPTION TO THE 10-YEAR TIME LIMITATION OF K.A.R. 82-3-111

COMES NOW, Karen Lee Byerley, Trustee of the Karen Lee Byerley Revocable Trust dated July 1, 2019 and Louise Ann West ("Protestors"), by and through Robert Eisenhauer of Johnston, Eisenhauer, Eisenhauer & Lynch, LLC, Pratt, Kansas, and pursuant to the Kansas Corporation Commission ("Commission") submit their protest against the granting of the Application of Canaday Oil Corporation for exception to the 10-year limitation of K.A.R. 82-3-111 for the Byerley #1-17 well located in Clark County, Kansas.

In support of this protest, Protestors state and allege as follows:

- 1. Protesters are the owners of an undivided 100% of the mineral interest in and under the Northwest Quarter (NW/4) of Section 17, Township 10 South, Range 24 West of the 6th P.M., Clark County, Kansas.
- 2. Protesters have filed an Affidavit of Non-Production with regard to the prior lease owned in part by Canaday Oil Corporation since the Byerley #1-17 well has not produced oil or gas in a number of years.

- Protesters state that Canaday Oil Corporation cannot obtain a temporary
 abandonment status for the Byerley #1-17 well, since there is no valid oil and gas lease where
 said well is located.
- 4. Grant Canaday, President of Canaday Oil Corporation, testified under oath in an evidentiary hearing held in the matter of the Application of Canaday Oil Corporation for an order authorizing the unitization and unit operation of the Irons Morrow Sand Unit in Clark County, Kansas, docket number 24-CONS-3103-CUNI, that the Byerley lease was not a valid oil and gas lease and had not been a valid oil and gas lease for more than seven years. (See Evidentiary Trial Transcript 14: 23-25.)
- 5. For some unknown reason, the Kansas Corporation Commission previously granted the applicant's application for temporary abandonment in August of 2024. Attached hereto as Exhibit A is a copy of correspondence dated August 27, 2024 from Michael Maier to the applicant stating that the TA states that the Byerley 1-17 will expire August 31, 2025.
- 6. It is the position of these Protestors that a well that has not produced oil and/or gas in paying quantities for years should be plugged as set forth under the rules and regulations of the Kansas Corporation Commission.

WHEREFORE, Protestors, Karen Lee Byerley, Trustee of the Karen Lee Byerly
Revocable Trust dated July 1, 2019 and Louise Ann West pray that the application in this protest
be set for hearing before the Commission; that upon receipt of testimony and other evidence
presented at a hearing, the Commission deny applicant's application and for such other and
further relief as the Commission believes is proper and authorized by the rules and regulations of
the Kansas Corporation Commission.
