6 On July 18, 2024, the Commission approved CP-111 which will expire on July 18, 2025.

7 F.G. Holl Company, LLC successfully tested the well's casing integrity on July 17, 2025.

See a report attached to the application.

8. Applicant wishes to obtain an exception to the 10-year well shut-in limitation because Applicant intends to use well for oil production. The Applicant has plans to re-complete well in Lansing-Kansas City Formation of the Pennsylvanian Group and put it back to production.

9. Applicant submits 'Well Information' in support of the Application. Copy is attached to the application.

10. Applicant has included a plat map showing the locations of all producing, injection, temporary abandoned, abandoned, and plugged wells located on the same leased premises as the subject well.

11. Based on the foregoing, Applicant requests the Commission to grant an exception to the 10-year limitation, specifically to allow the subject well to remain eligible for temporary abandonment status for three (3) more years. Applicant understands that the exception would be valid for three (3) years, but Applicant would still need to apply annually to the conservation division's district Office for approval of an application for temporary abandonment status.

12. Listed in the attached Exhibit "A" are the names and addresses of the following people:

A. Operator of each oil and gas lease covering lands within one-half (1/2) mile

radius of the subject well; and

B. Each person who owns any mineral interest of record in and under and lands located within one-half (1/2) mile radius of subject well (provided that such mineral interest is not covered by any oil and gas lease).

13. Notice of this Application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held on this matter will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, F.G. Holl Company prays that this Application be granted administratively without a hearing, or in the alternative be set for hearing, and upon hearing that the Commission grants Applicant's request for an exception to the K.A.R. 82-3-111 ten (10) year limitation, to allow the subject well to remain temporarily abandoned for three (3) more years, subject to annual approval by the Conservation Division Office of an application for temporary abandonment status.

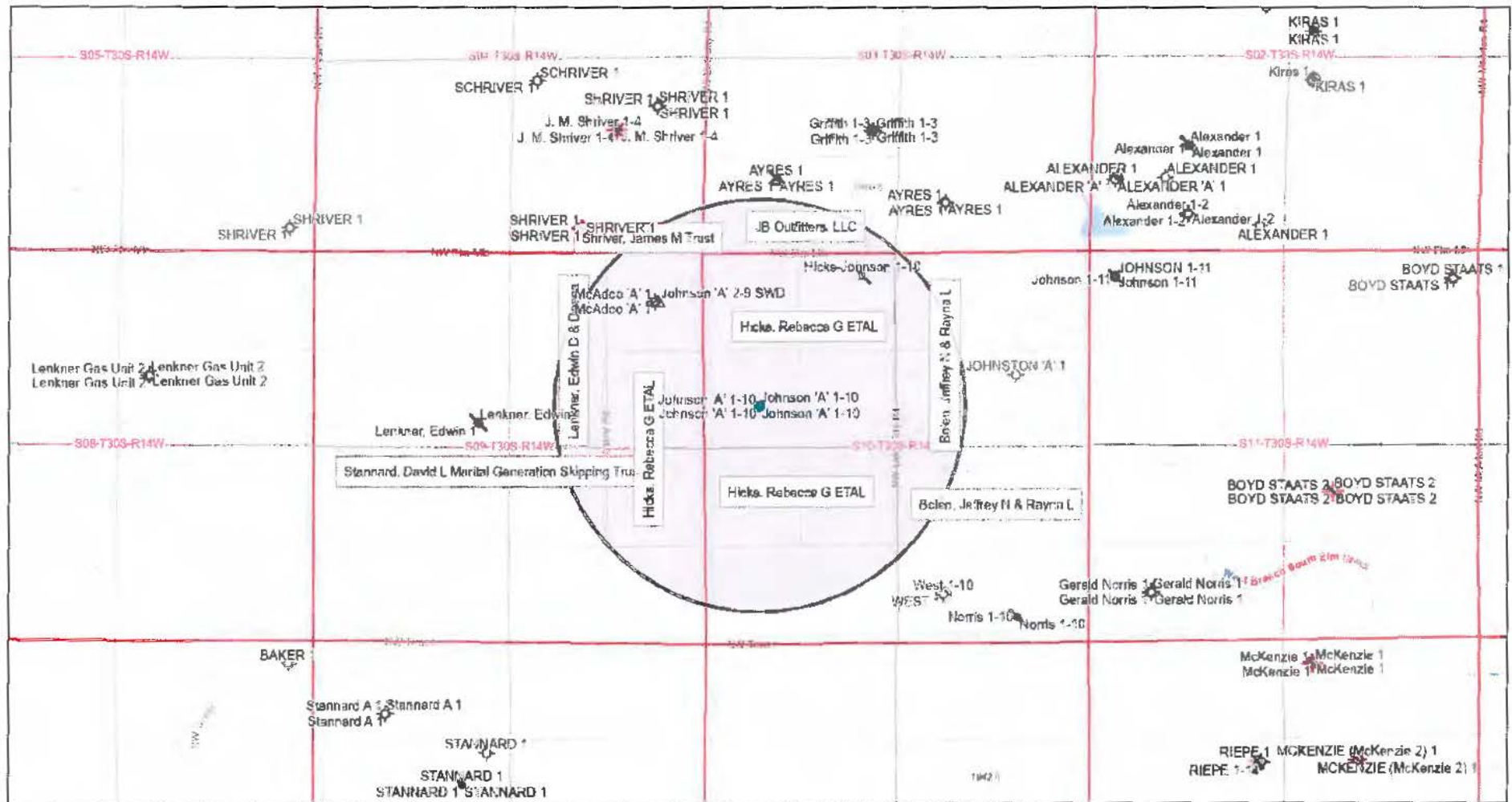

Lease Details:

- 1.0 Johnson "A" -10 lease is in NW/4 of Sec. 10-30S-14W. The lease has only one well, the Johnson "A" #1-10, located SW NW/4.
- 2.0 It would cost about \$30,000 to plug this well.
- 3.0 The well is shut-in from July 16, 2014, due to economic reasons. Cumulative oil production is 2,305.81 Barrels.
- 4.0 The well is already equipped to produce, and tank battery is in place. Operator's plan is to move in and recompleat in the Lansing-Kansas City Formation of the Pennsylvanian Group for oil. The recompletion cost is about \$30,000.

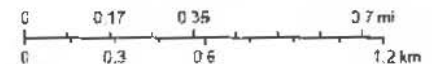
