**WITHDRAWAL OF MOTION TO SUSPEND INTRASTATE  
MOTOR CARRIER OPERATIONS**

The Staff of the State Corporation Commission of the State of Kansas (Staff), by and through its counsel, files a withdrawal of its motion to suspend Roadmasters Logistics LLC of Overland Park, Kansas (Carrier) from all intrastate commercial motor carrier operations. In support of its Withdrawal, Staff states as follows:

1. On May 24, 2022, the Commission issued Carrier a Penalty Order that assessed a civil penalty of \$300 for failure to pay the Unified Commercial Registration (UCR) fees for 2021. The order also required Carrier to pay its outstanding 2021 and 2022 UCR fees.
2. Carrier was sent a collection letter on June 30, 2022, reminding it of the amount due and giving it 10 days from the date of the collection letter to pay.
3. As of September 21, 2022, Commission records indicate that Carrier had not complied with the collection letter or the requirements of the Penalty Order.
4. On September 21, 2022, Staff filed its Motion to Suspend Intrastate Motor Carrier Operations.
5. On September 22, 2022, Carrier contacted Staff and paid its outstanding civil penalty as well as its UCR fees.

6. Carrier's actions obviate the need to be suspend the Carrier's intrastate motor carrier operations. Therefore Staff withdraws its motion and requests this docket be closed.

**WHEREFORE**, for the reasons stated above, Staff respectfully withdraws its Motion to Suspend Intrastate Motor Carrier Operations and requests this docket be closed.
