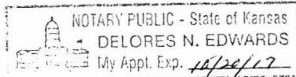

NOTICE OF APPLICATION
TO AMEND
INJECTION AUTHORITY
RE: PetroSantander (USA)

Inc.—Application for an amendment to the existing authority for the injection of saltwater for enhanced recovery purposes in the Christabelle (Morrow) Unit, located in Finney and Kearny Counties, Kansas; KCC Enhanced Recovery Injection Permit No. E-30071.

TO: All Oil & Gas Producers, Unleased Mineral Interest Owners, Landowners and all persons whom-ever concerned.

You, and each of you, are hereby notified that PetroSantander (USA) Inc. has filed an application to amend the existing injection authority for the injection of salt water into the Morrow Formation in the Christabelle (Morrow) Unit, by reactivating the following well as an injection well:

Scott #4-13, SW¼NW¼
13-21S-35W, Kearny Co.,
KS

The name of the operator of this enhanced recovery project is PetroSantander (USA) Inc. The legal description for the Scott 4-13 project acreage is the NW¼ of Section 13-T21S-R35W, Kearny County, KS.

The proposed maximum injection rate shall be 3000 barrels of water per day and the maximum injection pressure shall be 2000 psi. The proposed injection formation is the Morrow Formation, at the approximate depth of 4,875 feet subsurface. The proposed injection well conforms to minimum lease line distances according to existing fields rules, and is at an allowed distance from such lease and unit lines. The activation of this well will not exceed the number of injection wells previously authorized for injection by the Kansas Corporation Commission.

Any persons who object to or protest this application shall be required to file their objections or protest with the Conservation Division of the State Corporation Commission of the state of Kansas within thirty (30) days from the date of this publication. These protests shall be filed pursuant to commission regulations and must state specific reasons why granting an amendment to the existing injection authority may cause waste, violate correlative rights or pollute the natural resources of the State of Kansas.

All persons interested or concerned shall take notice of the foregoing and shall govern themselves accordingly.
