ORDER GRANTING MOTION FOR PROCEDURAL SCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings and conclusions:

1. On May 1, 2024, The Victory Electric Cooperative Association, Inc. (Victory) filed an Application to update its Local Access Delivery Service (LADS) tariff.¹ The Application was filed in accordance with Victory's 34.5 kV Formula Based Rate (FBR) approved in Docket No. 21-SEPE-049-TAR. Victory proposes to decrease the LADS demand charge assessed on the wholesale users of its 34.5 kV system from \$3.06 per kW to \$2.92 per KW.²

2. On June 18, 2024, Victory, Commission Staff, Kansas Municipal Energy Agency (KMEA)³, and Kansas Electric Power Cooperative, Inc. (KEPCo)⁴ filed a Joint Motion for Procedural Schedule.

3. The Commission approves the following procedural schedule:
