### ORDER REINSTATING MOTOR CARRIER OPERATING AUTHORITY

The above-captioned matter comes on for consideration and determination by the State Corporation Commission of the State of Kansas ("Commission") for consideration and determination upon its own motion. Having examined its files and records, the Commission, finds and concludes:

### I. Legal Standards

- 1. Pursuant to K.S.A. 66-1,108b, 66-1,111, 66-1,112, 66-1,114, 66-1,114b and 66-1,115, and amendments thereto, the Commission is given full power, authority and jurisdiction to supervise and control motor carriers, as defined in K.A.R. 82-4-3f, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority, and jurisdiction.
- 2. Pursuant to K.S.A. 66-1,129a, 66-1,130, and 66-1,142b, and amendments thereto, the Commission may suspend operations, revoke, or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in

regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision, or regulation of the Commission.

3. Pursuant to K.S.A. 66-1,129(a)(7), the Commission has adopted motor carrier transportation regulations (K.A.R. 82-4-3f) consistent with the federal motor carrier safety assistance program and other federal requirements concerning transportation of hazardous waste.

## II. Analysis

- 4. Bruce William Mooney d/b/a M's Skid Steer Work, formerly known as B & B Trucking Aggregate Hauling (M's Skid Steer Work or Carrier), is a motor carrier as defined in 49 C.F.R. 390.5 as adopted by K.A.R. 82-4-3f that operates commercial motor vehicle(s) in both intrastate and interstate commerce in a manner that requires authority.
- 5. M's Skid Steer Work is registered as a motor carrier with the U.S. Department of Transportation (USDOT) and operates under USDOT Number 3840982.
- 6. The Commission received notice from the U.S. Department of Transportation, Federal Motor Carrier Safety Administration that M's Skid Steer Work's New Entrant Registration had been revoked effective March 11, 2023, for failure to comply with safety requirements.
- 7. Pursuant to the above authority, on March 21, 2023, the Commission entered an Emergency Suspension of Operating Authority Order on M's Skid Steer Work in the above-referenced docket, until such time that Staff recommended reinstatement.
- 8. On May 9, 2025, the Staff of the Transportation Division of the Kansas Corporation Commission (Staff) received notice from the U.S. Department of Transportation, Federal Motor Carrier Safety Administration, that M's Skid Steer Work has submitted evidence

of compliance with safety requirements as required in 49 C.F.R. 385.329. As a result, the carrier's reapplication for New Entrant registration under USDOT No. 3840982 has been approved and the carrier's authority to operate in interstate operations has been reinstated. See attached FMCSA reinstatement documentation, a copy of which is attached hereto as Attachment "A" and is hereby incorporated by reference.

- 9. Carrier further submitted evidence of attendance at a Kansas Corporation Commission-sponsored safety seminar. A representative of Carrier attended on June 11, 2025. See attached KTRAN screenshot, a copy of which is attached hereto as Attachment "B" and is hereby incorporated by reference.
- 10. The Commission finds it has jurisdiction over M's Skid Steer Work because it is a motor carrier as defined in 49 C.F.R. 390.5 as adopted by K.A.R. 82-4-3f.
- 11. The Commission finds that by attending a Commission-sponsored safety seminar, M's Skid Steer Work has met the requirements of the March 21, 2023, Emergency Suspension of Operating Authority Order.
- 12. Based on the Federal Motor Carrier Safety Administration's reinstatement, the Commission concludes it should reinstate M's Skid Steer Work's motor carrier operations in Kansas.

#### THE COMMISSION THEREFORE ORDERS THAT:

A. The Kansas intrastate motor carrier operations of Bruce William Mooney d/b/a M's Skid Steer Work, formerly known as B & B Trucking Aggregate Hauling, are hereby reinstated.
