You and each of you are hereby notified that
WYNN-CROSBY OPERATING, LTD. ("Wynn-Crosby") has
filed an Application with the State Corporation Commission of
the State of Kansas (the "Commission") for the assignment of
a special allowable, pursuant to K.A.R. 82-3-133a(i), to the
Mayberry B-1 well for the production of gas from the Morrow
formation. The Mayberry B-1 well is located 1,500' FSL and
1,320' FEL of Section 12, Township 33 South, Range 38 West,
Stevens County, Kansas. Specifically, Wynn-Crosby seeks an
exception to produce gas from that well in excess of the statewide
allowable assigned by K.A.R. 82-3-304, and that such special
allowable be assigned retroactive to the date of first production.

The Application is pending before the Commission and
may be granted without a hearing unless, within fifteen (15)
days from the date of the publication of this notice, a written
protest is received by the Commission. Any such protest to the
granting of the Application should clearly state the grounds of
objection and should be mailed to both the Kansas Corporation
Commission, Conservation Division, 266 N. Main, Suite 220,
Wichita, KS 67202, and Wynn-Crosby or its counsel.

If a proper written protest is filed with the Commission
within fifteen (15) days from the date of publication of this
notice, this matter may be set for hearing by the Commission.
Any hearing will be held at the Commission Hearing Room,
Kansas Corporation Commission, 266 N. Main, Suite 220,
Wichita, KS.

All parties in any way interested or concerned shall take
notice of the foregoing and govern themselves accordingly.
