ORDER AMENDING PROCEDURAL SCHEDULE; DESIGNATING NEW PREHEARING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On May 1, 2018, Kansas City Power & Light Company (KCP&L) filed for a \$32.9 million revenue increase, including property tax rebasing.¹ As a result of its merger with Westar Energy, Inc., KCP&L has reduced its requested revenue increase to \$22.6 million.²
- 2. On June 26, 2018, KCP&L; Commission Staff (Staff); Walmart, Inc. (Walmart);³ Midwest Division OPRMC, LLC d/b/a Overland Park Regional Medical Center (OPRMC);⁴ Kansas Gas Service, (KGS);⁵ and the Citizens' Utility Ratepayer Board (CURB)⁶ filed a Joint Motion for Procedural Schedule.

- 3. On July 12, 2018, the Commission issued its Order Adopting Procedural Schedule With Modification. The two modifications involved the scheduling of the Public Hearing for August 23, 2018 and the Evidentiary Hearing for October 23, 2018.⁷
- 4. On July 31, 2018, the Commission issued an Order Designating a Prehearing Officer and Modifying Procedural Schedule to add a deadline to file public comments.⁸
- 5. On August 28, 2018, Michael J. Duenes, Assistant General Counsel replaced Dustin L. Kirk as Prehearing Officer.⁹
 - 6. The Commission adopts the following procedural schedule:

7. Although the Commission will conduct the evidentiary hearing, the Commission designates a prehearing officer to conduct any prehearing conferences that may be necessary, to

address any matters appropriately considered in a prehearing conference, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission designates Brian G. Fedotin, Deputy General Counsel, 1500 SW Arrowhead Road, Topeka, KS 66604-4027, telephone number (785) 271-3105, b.fedotin@kcc.ks.gov to serve as Prehearing Officer in this proceeding.¹⁰ The Commission may designate other staff members to serve in this capacity.

- 8. Finding that a prehearing conference is necessary to address any pending matters, to establish procedures to use during the Evidentiary Hearing, and to consider any other prehearing issues that will promote the orderly and prompt conduct of this proceeding, 11 the Commission schedules a Prehearing Conference for October 15, 2018, beginning at 1:30 p.m. in the Commission's Third Floor Hearing Room, 1500 S.W. Arrowhead Road, Topeka, Kansas. The Prehearing Officer will preside. Any party who fails to attend or participate in the Prehearing Conference or in any other stage of this proceeding may be held in default under the Kansas Administrative Procedure Act (KAPA). At the Prehearing Conference, this proceeding without further notice may be converted into a conference hearing or a summary proceeding for disposition of the matter as provided by KAPA.
- 9. An Evidentiary Hearing, with the Commission presiding, will begin on October 23, 2018 at 9:00 a.m., and continue, as needed, through October 26, 2018, in the Commission's First Floor Hearing Room, 1500 S.W. Arrowhead Road, Topeka, Kansas. Any party who fails to attend

or participate in the hearing or in any other stage of this proceeding may be held in default under the KAPA.¹⁴

- 10. The Commission encourages the public to submit comments concerning this docket via online at www.kcc.ks.gov, electronic mail, or in writing. The public comment period ends on October 17, 2018, at 5:00 p.m. By October 23, 2018, PACP is directed to file a report summarizing public comments received.
- 11. KCP&L, CURB, and PACP shall make information concerning the proceeding accessible to the public through use of their websites. These parties' websites should include links and contact information to enable the public to easily identify how to contact the PACP Office to submit comments and to access filings made in the docket. To the extent practicable, parties are encouraged to include background information explaining this proceeding.
- 12. The Commission approves the use of electronic service of all testimony, briefs, and orders, without requiring provision of follow-up hard copies as required by K.A.R. 82-1-216(a)(6). Testimony and briefs must be served electronically by 5:00 p.m., on the date due, without requiring service among the parties of a follow-up hard copy. The Commission directs electronic service of testimony and briefs include service on the Prehearing Officer at <u>b.fedotin@kcc.ks.gov</u>.
- 13. Amber Smith, <u>a.smith@kcc.ks.gov</u>, and Robert Vincent, <u>r.vincent@kcc.ks.gov</u>, 1500 S.W. Arrowhead Road, Topeka, Kansas 66604-4027, are the attorneys appearing on behalf of the agency in this proceeding.¹⁵
