MOTION FOR THE DESIGNATION OF A PREHEARING OFFICER AND THE SCHEDULING OF A PREHEARING CONFERENCE REGARDING CANCELLATION OF THE EUBANK SOUTH MISSISSIPPIAN-CHESTER SAND OIL AND GAS POOL ORDER

- 1. On November 12, 1996 the Commission issued an Order creating spacing rules for an area known as the Eubank South Mississippian-Chester Sand Oil and Gas Pool. The Order does little more than require 40-acre spacing for the area and formation in question, rather than allowing 10-acre spacing under the Commission's general rules. Staff believes the Order no longer serves any utility, and that the Order should be cancelled.
- 2. On March 18, 2016, Commission Staff sent a letter to all operators having wells within the Eubank South Mississippian-Chester Sand Oil and Gas Pool, stating that Staff was considering filing this motion, and asking for a response if any of the operators disagreed with Staff's belief that the Order should be cancelled. No operator responded.
- 3. Based upon the above, Staff moves that a prehearing officer be designated, and that a prehearing conference be scheduled, in anticipation of an evidentiary hearing regarding the cancellation of the Commission's Eubank South Mississippian-Chester Sand Oil and Gas Pool Order.
