WRITTEN REQUEST FOR HEARING**

**COMES NOW AGRICULTURAL ENERGY SERVICES, LLC** (hereinafter “Operator”) by and through its attorney, Lee Thompson, Thompson Law Firm, L.L.C., and for its written request for hearing in the captioned matter in accordance with the Kansas administrative procedure act and states as follows:

1. Operator is a limited liability company organized to do business in the State of Kansas and has been issued a license to conduct oil and gas activities by the Kansas Corporation Commission (“Commission”) under Operator License Number 34089.
2. On November 28, 2018, sent a Notice of Penalty Assessment to the Operator in connection with a Penalty Order alleging violation of K.A.R. 82-3-107 and K.A.R. 82-3-130.
3. A hearing is requested to address the issue of whether compliance with regulations by the Operator was timely and whether the penalty assessed is appropriate under the law and the facts.
4. The Operator had difficulty in filing information with the KCC and in any event the well has been completed and is now in compliance.
5. This Request for a Hearing is being filed out of an abundance of caution and to allow time to explore whether under the circumstances a fine is appropriate and authorized.
