In the Matter of the Audit of Nex-Tech Wireless, L.L.C. by the Kansas Universal Service Fund (KUSF) Administrator Pursuant to K.S.A. 2014 Supp. 66-2010(b) for KUSF Operating Year 18, Fiscal Year March 2014-February 2015.

Dear Ms. Gilbert:

On June 21, 2016, the Kansas Corporation Commission (KCC or Commission) issued an Order adopting GVNW Consulting, Inc.'s (GVNW) Audit Report and directed Nex-Tech Wireless, L.L.C. (Nex-Tech Wireless or Company), within sixty (60) days from the date of the Order, to: 1) submit Audit True-ups to the KUSF for Operating Year 18 and remit \$19,462.99 of additional assessments; 2) issue \$17,750.88 in refunds to its current Freedom Plan subscribers through one-time equal billing credits and provide GVNW with an affidavit executed by an officer of the Company attesting to completion of the refund and also provide GVNW with copies of customer bills substantiating the refund; 3) submit Audit True-ups for KUSF Operating Year 18 and 19 (March 2015 – February 2016) and pay the sum of \$29,282.46 to the KUSF; 4) refund \$48,709.89 to its current customers through one-time equal bill credits and provide GVNW with an affidavit executed by an officer of the Company attesting to completion of the refund and also provide GVNW with copies of customer bills substantiating the refund. The KCC Order further directed GVNW upon completion of the foregoing requirements to submit a Compliance Report.

On June 30, 2016, Nex-Tech Wireless provided the ordered Audit True-ups to GVNW and on July 19, 2016 remitted payments of \$19,462.99 and \$29,282.46 (\$48,745.45 total) to the KUSF.

On August 15, 2016, 2016 Nex-Tech provided copies of the required customer bills and submitted a notarized affidavit attesting to the issuance of the refunds to GVNW. The notarized affidavit is enclosed as Attachment A to this letter. GVNW recommends that Docket No. 16-NTWZ-030-KSF be closed.
