**ORDER DESIGNATING NEW PREHEARING OFFICER
AND AMENDING PROCEDURAL SCHEDULE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

1. On October 11, 2016, the Commission ordered IGWT, Inc. (Operator) to attend an evidentiary hearing to show cause why it is not responsible for the well or wells at issue in this proceeding.¹
2. On October 25, 2016, a Prehearing Conference was held in this proceeding where all parties agreed to a procedural schedule, including a January 19, 2017, evidentiary hearing.²
3. On November 28, 2016, Commission Staff filed a Motion for Continuance, requesting that the hearing scheduled for January 19, 2017, be continued to February 16, 2017.
4. In light of scheduling conflicts, the Commission finds that the evidentiary hearing in this docket shall be scheduled for Monday, February 20, 2017. The prefiling dates to accommodate the new hearing date shall be as follows:

5. The Commission also designates Michael J. Duenes, Assistant General Counsel, 1500 SW Arrowhead Road, Topeka, Kansas 66604-4027, telephone number (785) 271-3181, m.duenes@kcc.ks.gov, to serve as the new Prehearing Officer in this docket.³ The Prehearing Officer may conduct prehearing conferences necessary to address any appropriate matters, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other Staff members to serve in this capacity.

6. Although a Prehearing Officer is designated in this docket, parties are still required to file pleadings with the Commission, and filings shall be made with the Commission's Docket Room before 5:00 p.m., on the date scheduled for service. Any electronic service received after the deadline set forth in the procedural schedule, or any filing made after 5:00 p.m., on the date scheduled for service, shall be accompanied by a Motion to File Out of Time.

THEREFORE, THE COMMISSION ORDERS:


- A. Michael J. Duenes is designated as the new Prehearing Officer.
