# ORDER GRANTING APPLICATION TO CEASE TRANSACTING THE BUSINESS OF A TELEPHONE PUBLIC UTILITY

NOW, the above-captioned matter comes on for consideration and determination by the State Corporation Commission of the State of Kansas (Commission). The Commission, after giving due consideration to the Application and being fully advised in the premises, finds that:

1. The Application of Windstream Nebraska, Inc. (Windstream) in the abovecaptioned docket was filed with this Commission on August 1, 2019. A public hearing was not held on the instant Application.

2. The Commission's authority to supervise telecommunications public utilities derives from K.S.A. 2018 Supp. 66-1,188. The Commission's authority to certificate and decertificate public utilities derives from K.S.A. 2018 Supp. 66-131. Pursuant to K.S.A. 2018 Supp. 66-131, the Commission must review all certification and decertification applications to determine whether the public convenience will be promoted by granting the request.

3. Windstream requests permission to cease transacting the business of a telephone public utility in the following described territory:

Territory to be transferred to Blue Valley Tele-Communications, Inc. (Blue Valley) Oketo exchange from Windstream Nebraska's exchange territory :

Beginning at a point  $\frac{1}{4}$  mile south of the Kansas-Nebraska State Line and  $\frac{1}{4}$  mile east of the NW corner of Section 3, T1S, R8E, Marshall County, Kansas; thence north  $\frac{1}{2}$  mile; thence west  $\frac{1}{8}$  mile; thence north  $\frac{1}{4}$  mile, thence west  $\frac{1}{2}$  mile, thence south  $\frac{3}{4}$  mile, thence east  $\frac{5}{8}$  mile to the point of beginning.

4. Previously, on April 26, 2019, Blue Valley Tele-Communications, Inc. made a companion filing in Docket No. 19-BLVT-446-CXB requesting to transact the business of a telephone public utility in the territory described in paragraph 3 above.

5. With the granting of this instant application, the area of the Applicants exchange

territory will be described as follows:

# WINDSTREAM NEBRASKA's KANSAS TERRITORY BARNESTON/LIBERTY

From a point <sup>1</sup>/<sub>4</sub> mile east of the northwest comer of Section 5, TIS, R7E; thence south 1 <sup>1</sup>/<sub>4</sub> miles; thence west 1 mile; thence north 1 <sup>1</sup>/<sub>4</sub> miles to the Kansas-Nebraska State Line; thence east 1 mile to point of beginning

From the northeast corner of Section 3, T01S, R08E, thence south<sup>1</sup>/<sub>4</sub> mile; thence west 1/16 mile; thence south <sup>1</sup>/<sub>2</sub> mile; thence west 11/16 mile; thence north <sup>3</sup>/<sub>4</sub> mile; thence east <sup>3</sup>/<sub>4</sub> mile to the point of beginning.

From 3/8 mile west of the northeast corner of Section 4, T01S, R08E, thence south  $\frac{1}{4}$  mile thence west approximately 4 3/8 miles to a point  $\frac{1}{4}$  mile east and  $\frac{1}{4}$  mile south of the northwest comer of Section 2, TIS, R7E; thence south  $\frac{1}{2}$  mile; thence west 1  $\frac{3}{4}$  miles; thence north  $\frac{3}{4}$  mile to the Kansas-Nebraska State Line; thence east approximately 6 1/8 mile to the point of beginning.

From a point 1/16 mile west of the northeast corner of Section 2, T01S08E, thence south<sup>1</sup>/<sub>4</sub> mile; thence west 7/16 mile; thence north <sup>1</sup>/<sub>4</sub> mile; thence east 7/16 to point of beginning.

6. Staff identified a difference between what the Commission records indicate the proper exchange name for the territory above is and what Windstream describes as the exchange for the area covered by this Application. The Commission records indicate the legal description

is part of the exchange described as Windstream Nebraska's Liberty Exchange, whereas Windstream indicates it is the Barneston exchange. Because of employee succession at Windstream, the Commission Staff was unable to determine the appropriate exchange name designation. The Commission did not have jurisdiction over Windstream with the exchanges being principally located in Nebraska with a portion of the exchange boundaries extending into Kansas. Consequently, the territory will be referenced as the Windstream territory and not the specific Windstream exchange name. Attachment A to the Order confirms Windstream's general understanding of the acreage to be transferred to Blue Valley.

7. The Commission finds that public convenience will be promoted by granting the instant Application authorizing Windstream to cease transacting the business of a telephone public utility in the territory described in paragraph 3 above.

# IT IS THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Application filed by Windstream Nebraska, Inc. on August 1, 2019, is hereby granted and Windstream is authorized to cease transacting the business of a telephone public utility in the territory described in paragraph 3 above.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>1</sup>

C. The Commission retains jurisdiction over the subject matter of this Docket for the purpose of entering such further Order or Orders as it may deem necessary.
