**NOTICE OF FILING OF STAFF'S  
REPORT AND RECOMMENDATION (PUBLIC)**

COMES NOW, the Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission,” respectively), and files the instant Report and Recommendation (“R&R”) regarding the Joint Application of Sunflower Electric Power Corporation (“Sunflower”) and Lane-Scott Electric Cooperative, Inc. (“Lane”) for approval of the Firm Energy, Capacity, and Load Following Agreement (“Agreement”) by and between Sunflower, Lane, and the City of Dighton (“Dighton”).

Based on its analysis of the Joint Application, Staff determined that the proposed Agreement would benefit Sunflower, Lane, and Dighton by retaining the City’s load, lowering Sunflower Member costs, and reducing electricity rates, respectively. Therefore, Staff recommends the Commission find the same and approve the Agreement.

Staff’s Report and Recommendation contains confidential commercial information pertaining to certain portions of the Agreement; therefore, Staff has elected to file both a confidential and public version of the Report and Recommendation in accordance with K.S.A. 66-1220a.

WHEREFORE, Staff submit their Report and Recommendation for Commission consideration and for such other relief as the Commission deems just and reasonable.

**SUBJECT:** Docket No. 25-SEPE-284-CON – In the Matter of the Joint Application of Sunflower Electric Power Corporation and Lane-Scott Electric Cooperative, Inc., for Approval of the City of Dighton Firm Energy, Capacity, and Load Following Agreement.

**EXECUTIVE SUMMARY:**

On January 21, 2025, Sunflower Electric Power Corporation (“Sunflower”) submitted an Application to the Kansas Corporation Commission (“Commission”) requesting approval of the Firm Energy, Capacity, and Load Following Agreement (“Agreement”) between Sunflower, Lane-Scott Electric Cooperative, Inc. (Lane-Scott) and the City of Dighton, Kansas (“Dighton” or “City”). Staff performed an analysis to ascertain the benefits that the proposed Agreement would provide to Sunflower, Lane-Scott and Dighton, if approved. As a result of this analysis, Staff concluded that the proposed Agreement will ultimately benefit all the parties involved and, therefore, recommends Commission approval of the Agreement.

**BACKGROUND:**

Sunflower and Lane-Scott, as cooperatives, have elected to be exempt from the jurisdiction, regulation, supervision and control of the Commission pursuant to K.S.A. 66-104d(f). However, according to this statute, a self-regulated cooperative remains subject to the regulation of the Commission for sales of power for resale to non-member-owners. Since Dighton is not a member-owner, this aspect of the proposed Agreement falls under the jurisdiction of the Commission.

The current Firm Energy, Capacity, and Load Following Agreement between Lane-Scott and Dighton was entered into in 2014 and is set to expire on December 31, 2024. Lane-Scott began billing Dighton at the lower proposed agreement rate on January 1, 2025, to avoid owing Dighton a credit for services provided, per Section 3.1 of the proposed agreement. The proposed Dighton Agreement in the present Docket will supersede the current Agreement for the City, if approved.<sup>1</sup>


