MOTION TO VACATE ORDER GRANTING APPLICATION

Comes the Staff of the Kansas Corporation Commission (Staff) and moves the Commission to vacate its Order Granting Application in this docket. In support of its motion Staff alleges the following:

- 1. The application is this docket was filed on April 18, 2016. The application requested a well location exception in accordance with K.A.R. 82-3-108(c) for a residential gas well because the proposed well would not meet the required setbacks and there would be less than the required 10 acres to attribute to the well.
- At Staff's request the Commission issued its Order Granting Application on May
 3, 2016.
- 3. Following the issuance of the Order by the Commission, Staff received information that the notice mailed to offset mineral owners was not sufficient to advise them of their right to protest.
- 4. Staff investigated this allegation and determined that the notice mailed to offset mineral owners was indeed defective. Staff advised the applicant's consultant that new notices needed to be mailed to offset mineral owners.

- 5. New notices meeting Commission regulations were mailed to offset mineral owners May 27, 2016.
 - 6. Protests to the application were timely filed requiring an evidentiary hearing.

Therefore, Staff moves the Commission to vacate its May 3, 2016 Order in this docket so that a Prehearing Officer can be appointed and a prehearing conference scheduled in this docket.
