COMES NOW Applicant, Kansas Gas Service Company, a division of ONEOK, Inc. ("Kansas Gas Service") and files this motion pursuant to K.A.R. 82-1-222 and K.S.A. 77-516 and 77-517. In support of this Motion, Kansas Gas Service states as follows:

- 1. Kansas Gas Service is a corporation duly organized under the laws of the State of Kansas, with a principal place of business at 7421 West 129th Street, Overland Park, Kansas 66213.
- 2. Kansas Gas Service is duly authorized to transact the business in the state of Kansas, holds appropriate certificates from this Commission to transact business as a natural gas public utility, and is now and has been engaged in the purchase, transmission, sale and distribution of natural gas in the state of Kansas in accordance with the laws of said state and the rules and regulations of this Commission.
- 3. On June 21, 2001, the Commission issued an Order in Docket No. 106,850-U (75-GIMC-009-GIG). In that Order, the Commission ordered Kansas Gas Service and other natural gas utilities in the state to file with the Commission monthly contract summary filings and an annual written report relating to supply and transportation contracts and purchasing practices. The Order indicated that the filings should be made in utility-specific dockets.
 - 4. The purpose of this Motion is to request that the Commission establish a scheduling

conference among the parties in the above-captioned matter, to discuss, and hopefully agree, to a schedule regarding the annual meeting to review and discuss the utility's gas portfolio, contracts and purchasing practices, as required by the Commission in its Order dated June 21, 2001, in Docket No. 106,850-U (75-GIMC-009-GIG).

WHEREFORE, for the reasons set forth herein, Kansas Gas Service requests that its Motion for Scheduling Conference be granted.
